

For those of you who may not know why I am so passionate and dedicated to accomplishing this goal, allow me to share some of my personal history with you. My name is Alisha Owen.

I was a victim\witness in what became known as the Franklin Credit Union Scandal. The similarities between my case and the Epstein case are too obvious to ignore. This must be stopped.

What makes my story so unique is the lengths government officials went to in order to extinguish any meaningful or transparent investigation and accountability for the predators and government officials whose actions or negligence covered up the child trafficking network that ensnared me.


Join me in accepting nothing less than justice.

#### Epstein News: March 2024

Florida Governor Ron DeSantis signed legislation that will open the records of the state grand jury that initially indicted Jeffrey Epstein in 2006. But the law still allows for some redactions, doesn't take effect until July, and until then, the records will remain sealed.

A group of 12 victims of Jeffrey Epstein are suing the FBI for failing to protect them. Here's hoping they have better luck than the scores of other Epstein victims at getting justice.

Despite a Federal Bureau of Prisons investigation clearing itself of any wrongdoing, Jeffrey Epstein's brother continues to insist the child sex trafficker didn't kill himself while in federal custody.

Some of the most important people in the financial industry helped enable Jeffrey Epstein continue his child sex trafficking operation, even years after his conviction as a sex offender.

Documents released earlier this year again reveal the high-profile people in business and government with whom Jeffrey Epstein associated. When might a real investigation into these associates happen?

Jeffrey Epstein's primary accomplice in his child sex trafficking operation, Ghislane Maxwell, has earned her place in a federal prison "honor dorm" for "good behavior" as she serves a 20-year sentence. It's hard to imagine a clearer perversion of justice

## The Epsicin Pimps

According to Black's Law Dictionary, a pimp is "the name that describes a person who procures prostitutes for the people."

A New York Times article from August 30, 2019 named six pimps who facilitated Jeffrey Epstein's sexual trafficking of minors.

The six pimps were Ghislaine Maxwell, Leslie Groff, Sarah Kellen, Adriana Ross, Nadia Marcinkova, and Haley Robson.

The Times article served up six child traffickers to the Department of Justice, but it merely indicted one of them—Maxwell. The article and the subsequent actions by the Justice Department demonstrates, absolutely, that our government is in the business of covering up child trafficking, which, in legalese, translates into aiding and abetting.

Numerous Americans are experiencing cognitive dissonance as they grapple with the horrific reality that their government is adding and abetting child trafficking. But they have nonetheless accepted that a perfidious rot is eroding a government that is ostensibly by the people and for the people, because the Congressional approval rating hovers at 17%.

We, as Americans, would never trust an individual or group that aids and abets child trafficking.

So, at this point, how can we trust our government?

#### TAKE ACTION

The House's Committee on Oversight and Reform started an investigation into the child trafficking network of Jeffrey Epstein.

The Committee sent <u>a letter to Florida authorities</u> that states: "The Committee requests that FDLE [Florida Department of Law Enforcement] produce, by January 3, 2020, all the documents, including email communications, its possession regarding the investigation and prosecution of Mr. Epstein..."

We have sent emails to House's Oversight Committee regarding the prospective investigation, and we have yet to a peep.

In addition to sending an email to the House's Committee on Oversight and Reform, you can sign the Epstein Justice petition and also send a form letter to your federal representatives.


## Person of Interest

Billionaire Les Wexner had various ties to Jeffrey Epstein, and, according to two sources, his bond to Epstein was extremely sordid. In a defamation lawsuit, Virginia Giuffre, one of Epstein's underage victims, <u>accused</u> Wexner of molesting her as a minor.

A house manager of Epstein's, Alfredo Rodriquez, also named Wexner as a perp vis-à-vis Epstein's Black Book. In 2009, Rodriquez made a copy of Epstein's Black Book, and his grand plan was to hawk the Black Book to an attorney representing some of Epstein's victims in civil lawsuits—his fee was \$50,000. The attorney in question reported Rodriquez's hijinks to the FBI, which snared Rodriquez and the Black Book in a sting.

The FBI had previously interviewed Rodriquez, but he had said nary a word about the Black Book, so he was charged with federal obstruction of justice. After the FBI busted Rodriguez attempting to peddle the black book, one of the arresting agents stated in an <u>affidavit</u> that the Black Book had the "names and contact information of material witnesses…" Rodriguez maintained that the individuals whose names were circled in the Black Book were in cahoots with Epstein regarding his pedophile network.

#### LES WEXNER



The assistant US attorney prosecuting Rodriguez was Ann Marie Villafana, and she did not veer from Justice Department's pattern of disingenuousness. Villafana told the judge in Rodriguez's case that his failure to yield the Black Book was a lost opportunity for the government's Epstein investigation. But she neglected to mention that the Justice Department didn't even need the Black Book to prosecute Epstein for pedophilic offenses, because it already possessed a list of 32 underage victims.

Epstein and Wexner have a rather enigmatic relationship. In 1985, The Evening Standard reports, the talented Mr. Epstein started to orbit Wexner. Epstein then became an increasingly ubiquitous force in Wexner's corporate concerns. By 1991, Wexner conferred Epstein with power of attorney over his vast empire, essentially giving Epstein the keys to his kingdom.

Wexner's friends and colleagues were perplexed by their mysterious relationship. After Epstein's arrest on July 6, Wexner wrote a letter to L Brand employees vowing that he was "NEVER aware of the illegal activity" charged in Epstein's latest indictment. In early 2006, however, Palm Beach police charged Epstein with multiple counts of child molestation, but it took Wexner 18 months after the fact to ostensibly severhis connection to Epstein.

Despite their purported 2007 rupture, one of Wexner's charitable foundations received a \$56 million infusion from a trust linked to Epstein in 2011. Also in 2011, the deed to Epstein's Manhattan mansion was transferred from a Wexner-owned concern to an Epstein company based in the U.S. Virgin Islands. Wexner, too, claims that he discovered Epstein embezzled"vast sums" of money from him in 2007, but he never notified authorities.

Epstein appears to have been a blackmail artist, but his marks would never voice that inconvenient truth. Blackmail marks, especially politicians and power brokers, have zero incentive to turn to the authorities if the blackmailer has pictures of their illicit, highly aberrant, or extramarital sexual conduct. Those pictures, released to the public, would doom their careers, probably destroy their families, and reduce their lives to public ignominy.

Epstein, however, as a lone college dropout from Coney Island, could not have blackmailed powerbrokers with impunity. Such men can have access to ruffians, murderers, and even organized crime. Les Wexner is an example of an alleged perpetrator who has had purported ties to organized crime. Wexner is a denizen of Ohio, and his L Brands is headquartered in Columbus, Ohio. A 1991 report from the Columbus Division of Police (CDV) implicates Wexner in a 1985 murder and also discusses his possible affiliation with the organized crime. The report focuses on the execution style murder of Columbus attorney Arthur Shapiro whose law firm represented Wexner's clothing empire. Shapiro took two bullets to the back of the head in broad daylight, and the CDV report notes that his murder had the distinct signature of "Mafia" hit. The CDV report that fingers Columbus' most lionized citizen in a Mafia hit was ordered to be destroyed by CDV Chief James Jackson, who would be reprimanded for ordering the report's destruction.

The CDV report describes, Walsh Trucking Company, owned by Frank Walsh, as a "major trucking company for The Limited." The CDV report also notes Walsh's connection to the Mafia. A 1987 Women's Wear Daily article states that "Walsh had done in excess of 90 percent of Limited's business," accounting for \$73,600,000. And a 1996 article from Bergen County's The Record chronicles Walsh's guilty plea for bribing Teamster officials and mail fraud and that "federal prosecutors" had concluded Walsh was an appendage to the "Genovese" crime family.

Wexner had known sociopathic pedophile Epstein for approximately six years when he handed Epstein the keys to his kingdom. As I mentioned, the mysterious relationship between Wexner and Epstein befuddled his friends and colleagues. In August of 2019, Vanity Fair published an apologetic on behalf of Wexner, "HE PICKS THE WRONG FRIEND, THEN THERE'S ALL HELL TO PAY': HOW JEFFREY EPSTEIN GOT HIS HOOKS INTO LES WEXNER," which sought to explain the bizarre relationship between Wexner and Epstein. The Vanity Fair article was mind-boggling in either its seismic naivete or disingenuousness: The article determined that Wexner's "loneliness" made him susceptible to being bamboozled by conman Epstein.

But according to Virginia Giuffre and Alfredo Rodriguez, their relationship had far more sinister undertones. Although Wexner claims that Epstein embezzled "vast sums" of money from him, he never notified authorities about Epstein's grift. If loneliness drove Wexner to befriend Epstein, then common sense almost certainly dictates that Wexner would request law enforcement intervention to retrieve the "vast sums" purloined by Epstein. But if their relationship was rooted in the claims of Giuffre and Rodriguez, then Wexner's actions, or lack thereof, would be understandable.

# Unprecedented: US Congressman Says His Colleagues are Blackmailed

In December, U.S. Representative Tim Burchett made a stunning confession: his colleagues are being blackmailed. He said that his congressional colleagues may be on a trip or at a bar, and they meet someone and buy them a drink. "Next thing you know, you're in a hotel room with them, naked," said Burchett on The Benny Show. Next thing you know, you're about to make a key vote, and what happens? Some well-dressed person comes up and whispers into your ear, 'Hey, man, there's tapes out on you. Were you in a motel room on whatever with whoever?' And then you're, like, 'Uh-oh.' And they say, 'You really ought not be voting for this thing.'"

I've written one book and co-authored a second book about sexual, political blackmail in American politics. I've found that Americans have a collective naiveté about their politicians' sexcapades, believing that they are the dalliances and moral failings of a select few. My fellow Americans have great difficulty accepting that many of our politicians are endowed with a potent psychological alchemy of power, arrogance, and lust that fluently translates into extramarital affairs, aberrant behavior, and even illicit deeds. Alas, whenever libido drives the car it invariably parks in the wrong garage.

Sexual, political blackmail is a time-honored tradition in America. The husband of Alexander Hamilton's 23-year-old mistress financially extorted Hamilton to ensure that his affair remained surreptitious, but a muckraking journalist exposed Hamilton's affair. Hamilton and Jefferson were antagonists, and the muckraker who outed Hamilton's extramarital affair felt that Jefferson owed him a political appointment when Jefferson became president. But Jeffersondeclined, so the muckraker disseminated news about Jefferson's affair with one of his slaves. Although a procession of hagiographies have elevated America's Founding Fathers to saint-like status, they, nonetheless, had their sexual foibles that made them susceptible to blackmail.

In the previous 20 years, the following U.S. senators and representatives have been entangled in sexual scandals: Gary Condit, Ed Schrock, Steven C. LaTourette, David Dreier, Don Sherwood, Mark Foley, David Vitter, Larry Craig, Tim Mahoney, Vito Fossella, John Edwards, John Ensign, Chip Pickering, Eric Massa, Mark Souder, Christopher Lee, Anthony Weiner, Scott DesJarlais, David Wu, Vance McAllister, Blake Farenthold, Dennis Hastert, Tim Murphy, Al Franken, Joe Barton, Trent Franks, Matt Gaetz, Katie Hill, Cal Cunningham, John Conyers and, last but probably not least, Pat Meehan

The aforementioned names are merely the U.S. representatives and senators whose sexcapades have pierced the mainstream media. The majority of Americans are probably cognizant of Hollywood Babylon, but Sodom and Gomorrah on the Potomac seems to be largely overlooked. I'll comment on two of the formerly esteemed men that I've cited, and they should give the reader an idea of the relative ease a third party would have compromising a politician and also of the mindboggling risks politicians will take to satiate their lusts.

Former U.S. Senator Larry Craig was in Washington, D.C. as a congressman for more than 25 years. During his tenures as a U.S. representative and a senator, his voting record for gay-rights legislation was deplorable, even though he used the services of a gay escort service. Craig was an unrepentant conservative, so, if his homosexual endeavors were exposed, his political career would ignominiously crash and burn. But, nonetheless, Craig was arrested for lewd conduct in a restroom at the Minneapolis-St. Paul International Airport: He propositioned an undercover male police officer in a bathroom stall.

Republican Dennis Hastert was the former Speaker of House from 1999 to 2007. During those years, he was constitutionally the third most powerful man in the country, and he established a reputation in the House as being a strong-arm specialist. Hastert, however, had concealed pedophilic predations for decades throughout his meteoric political ascent. As the revelations about Hastert became increasingly sordid, and the story incited a media feeding frenzy, a federal judge, siding with federal prosecutors, ruled that discovery in the case would not be made public. Then, suddenly, the news about Hastert's predatory behavior quickly evaporated.





Hastert's illicit sex with minors stunned a nation. But in a 2006 investigation, the House Ethics Committee ruled that Hastert and other Republicans were "willfully ignorant" for months in their response to recurring warnings that U.S. Representative Mark Foley was preying on teenage, congressional male pages. In 2009, an F.B.I. whistleblower testified during a deposition that the F.B.I. was cognizant of Hastert visiting a Chicago townhouse for "not very morally accepted activities" during his speakership. If the whistleblower's revelations are true, then F.B.I. personnel were aware of Hastert's shadow life, but, yet, he was publicly unscathed by it during his years as Speaker of the House.

Political blackmail is rarely made public, and if it becomes public, then it generally occurs years after the fact. J. Edgar Hoover is a prime example: He was a blackmail artist for decades, and his blackmailing only emerged years after his death. Blackmail marks, especially politicians, have zero incentive to turn to the authorities if the blackmailer has pictures of their extramarital flings and/or aberrant behavior. Those pictures, released to the public, would doom their careers, probably destroy their families, and reduce their lives to public ignominy.

Bottom line: If love is blind, then lust is deaf, dumb, and quadriplegic.

Teresa: I'm very grateful for Epstein Justice. It's been a long time coming. Epstein Justice is taking the necessary steps to an actual justice. Through consistently taking actions and paving the road to justice, we can attain justice.

Teresa: I'm honored and proud to be on the advisory board of Epstein Justice.
