


Our actions can be epic.

In the early evening of December 1, 1955, in Montgomery, Alabama an African-American woman, Rosa Parks, boarded a bus, paid her fare, and sat in an empty seat in the first row of back seats reserved for African Americans in the "colored" seating in the back of the bus. As the bus traversed its regular route, all of the white-only seats in the bus became filled up. In front of Montgomery's Empire Theater, several white passengers boarded the bus, and the bus driver noticed three white passengers were standing. The bus driver then moved the "colored" section sign behind Parks and demanded that four African Americans surrender their seats to the white passengers who were standing. "When that white driver stepped back toward us," Rosa recalled, "he waved his hand and ordered us up and out of our seats, I felt a determination cover my body like a quilt on a winter night." Rosa refused to surrender her seat, and she was arrested.

Those percentages are considered to be extremely conservative by experts in the field of child abuse, especially as they apply to boys, but the CDC percentages nonetheless translate into 50 million Americans that are molested as girls and boys. According to the <u>Safe House Project</u>, 300,000 American children are victims of commercial sexual exploitation each year. The average age of entry into the commercial sex market is 12 years old. The average victim is held captive for 23.4 months before escaping, dying, or being set free. In the US, 1 in 6 reported endangered runaways are believed to be victims of child sex trafficking.

Unfortunately, our society will never eradicate child sexual abuse and trafficking. However, we can take a major step in the eradication of child trafficking by ensuring that our local, state, and federal governments do not cover-up child trafficking.

Epstein Justice was granted 501(c)(3) status in July of last year, and we're growing, albeit slowly, because grassroots movements are never an easy undertaking. The segregation in the south was unequivocally wrong, and the cover-up of the Epstein child sex trafficking network is unequivocally wrong, too. Just as Rosa Parks expressed her humanity and stood up to evil on a bus on December 1st 1955, we must express our humanity and challenge the government cover-up of Jeffrey Epstein's child trafficking network. Generally in life, we almost always know the things we absolutely shouldn't do, but the things we absolutely should do can often be ambiguous. representative directly.

As of today's writing, there are 23 members of the House from 16 states that are supporting this Bill. The "Franklin" and Epstein cases demonstrate that the "system" is impeccably capable of covering up the most heinous of crimes—child sex trafficking. But "Franklin" and Epstein are definitely not lone examples of the system covering up the crimes of elite predators. Marney Rich Keenan wrote The Snow Killings: Inside the Oakland County Child Killer Investigation, and it demonstrates how a network of child predators and killers in and around Detroit was covered up. During thirteen months in 1976 and 1977, four children were abducted, abused in captivity, and murdered.

Mark Stebbins: 12; February 15, 1976 Jill Robinson: 12; December 22, 1976 Kristine Mihelich: 10, January 2, 1977 Timothy King: 11; March 16, 1977

The Task Force, however, didn't investigate whether or not there was a link between Sheldon's network and the snow killings.

The case gathered dust for more than 30 years, when Detective Cory Williams became the lead detective on the case. Williams was a detective for the Livonia Police Department—Livonia is a suburb of Detroit. Williams was 15 years old when the 3rd victim, Kristine Mihelich, went missing, and he was the son of a detective who had worked the snow killing case.

In 2005, Cory Williams was assigned to investigate a 13-year-old cold case murder that he ultimately solved: Richard Lawson was the murderer. He was an inveterate pedophile, too. Vying for leniency, Lawson discussed the child prostitution and pornography network operating near Detroit in the Cass Corridor. Lawson told Williams that he and others were pandering children from the Cass Corridor to automobile executives in the suburbs.

Lawson also coughed up the name of Ted Lamborgine who was indicted for molesting over 12 boys. He was arrested in 2007 and given 3 life sentences. Lamborgine failed a polygraph on the snow killings, but he refused to help police solve the crimes.

The children's bodies were dumped by public roadsides in Oakland County, Michigan, which is north of Detroit. Their murders are called the snow killings, because the kids went missing when it snowed. Law enforcement believed that the children knew their abductor.

Law enforcement launched the Oakland County Child Killing Task Force in 1977 to apprehend the killer of killers. It costed \$1million and fielded 18,000 tips. It was the largest manhunt in the US at the time, but the Task Force failed to make a single arrest.

In July of 1976, as the Task Force was investigating the snow killings, Gerald Richards, an elementary school gym teacher, was arrested for child pornography. Richards told police about a massive pedophile network that was financed by Francis Sheldon, an affluent scion. Sheldon bought Fox Island where children were flown in and out of, pandered and also filmed. Sheldon fled after Richards edified the police about him, and he jumped from country to country, avoiding extradition with the help of his family's money and lawyers. (Richards provided law enforcement with a diagram that showed the numerous shocking tentacles of the Detroit pedophile network.)

Patrick Coffey was a childhood friend of Tim King's, the fourth murdered child. He had become so traumatized by Tim's murder that he became a polygraph examiner. In July of 2006, Patrick gave a presentation to the American Polygraph Association in Las Vegas, and Larry Wasser was sitting in the audience. Wasser had been the president of the Michigan Association of Polygraph examiners. After Patrick's presentation, Wasser introduced himself to Patrick.

Patrick told Wasser why he became a polygraph examiner. Wasser was acutely aware of the snow killings, and he disclosed that he polygraphed a man who confessed to the murders. In divulging this information, Wasser violated attorney-client privilege.

Wasser quickly fell silent, but Patrick rushed to the phone, and told his family he had a lead on the killer of Tim King. Wasser fought a subpoena all the way to the Supreme Court, and it took nearly two years to determine the suspect Wasser had pegged—Christopher

Christopher Busch had previously been indicted for child molestation four times, and lived in a 5-mile radius of where the bodies were found.

Years earlier in 1977, a fellow predator and friend of Christopher Busch, Greg Greene, had been arrested for molesting underage boys. Greene also matched a police sketch of a man talking to Tim King before his abduction.

When Greene was interrogated, he confessed that Busch had murdered Mark Stebbins, the first victim of the snow killings. Busch was picked up for questioning. When asked where he picked up children, Busch cited the first 3 abduction sites in chronological order.

# The Snow Killings

The Task Force was alerted to Busch, and Assistant District Attorney of Oakland County Richard Thompson interviewed Busch and Greene. He was adamant that Busch should not receive any plea deals. But Busch merely received probation for four counts of raping minors. Thompson maintains he didn't remember the name Christopher Busch and disavows interrogating him.

During the time of Busch and Greene's arrest, L. Brooks Patterson was the District Attorney of Oakland County, and he was running for the United States Senate. Keenan surmises that when Busch was arrested, Brooks sought to curry favor with an influential and powerful constituent: Christopher Busch's father, H. Lee Busch, a senior financial director for GM, by offering to protect his son. Subsequent evidence was found demonstrating that the polygraph taken by Christopher Busch was doctored in order to exonerate Busch of the murders.

Keenan also discovered that Patterson received a \$10,000 contribution for his Senate campaign from Albert Thompson who was the father of one of the detectives working the case. Thompson was a retired auto assembly line worker living on a small pension and could hardly afford that sum of money. Thompson's check was deposited at the same time Christopher Busch's lawyers were

pleading for leniency, and Busch received leniency to the third power.

Keenan believes that protecting Christopher Busch in exchange for a campaign donation from his father seemed like a minor transgression to the prosecutors, because they thought Busch was merely a molester, not a child murderer.

However, when Tim King was murdered after Busch's release, the prosecutors probably realized that they had essentially freed a child murderer. Thus began the destruction of evidence, false statements to the media, and the full throttle cover-up. The community was kept in the dark about the malfeasance of the Oakland County prosecutor's office and the families of the victims would be traumatized for decades without resolution.

In late November 1978, a year after the child murders stopped, Christopher Busch was found dead in his home from an ostensible self-inflicted gunshot wound to his head. But the evidence bellied the police cover story, because the suicide had been so obviously staged. There was no blood spatter on the walls and his sheets were pulled up as if he were sleeping. There was no gun powder residue on his hands. Bush's body was cremated 2 days later. Within a month of the suicide, the Task Force closed, declaring it was out of money.

However, Busch's polygraph about the snow killings was doctored. And Christopher Busch's friend, John Hastings, egregiously failed a polygraph on the case in 2009. The polygraph examiner declared that there was no way Hastings didn't have involvement


#### in the snow killings. But law enforcement never followed up with him.

James Gunnels was a 13-year-old victim of Busch who also became a perp. His mitochondrial DNA was found to have the same consistency of a hair found on Kristine Mihelich. Gunnels also failed a polygraph on Mihelich's murder, but he refused to talk about it.

Paterson never relinquished his power in Oakland County. After 16 years as the Oakland County prosecutor, he was elected to the office of Oakland County Executive and served in that capacity until his death in 2019. Both positions allowed Patterson to be the ultimate gatekeeper of his own crimes.

In 1975, Patterson told a reporter that his dreams and ambition included a run for the White House. Despite his lust for power, Patterson never came close to the US Senate, but he was nonetheless covered up the most heinous of crimes.

A commonality among the Epstein, Franklin, and the network producing the snow killings was that the pedophiles could be extremely sadistic. One Epstein victim told me that one of her perpetrators was so violent that she had to be hospitalized. Two victims of the Franklin network discussed witnessing homicides of children, and additional polygraphs indicate that Busch may not have been the lone murderer in the snow killings.



A second commonality among the three networks is that they were covered up. According to state and federal law enforcement, the Franklin network never existed. And although the existence of the Epstein network has been acknowledged by law enforcement, none of the perpetrators, with the exception of Ghislaine Maxwell have been prosecuted. So for all intents and purposes, the Epstein network has been covered up. The snow killings would've been immaculately covered up if two polygraph examiners didn't have a chance meeting at a 2006 conference of the American Polygraph Association in Las Vegas.

# An Interview with Epstein Victim Juliette Bryant



Epstein Justice: How did you meet Jeffrey Epstein?

Juliette: Epstein and Bill Clinton were traveling together in South Africa, where I lived. Epstein then recruited me to be a model, and the next thing I knew I was on a plane to New York. I told Epstein that I didn't have any money, and he said that my expenses would be deducted from the money I earned modeling. The flight from South Africa to New York is about 20 hours, and I barely slept. I was extremely excited, because I thought all of my dreams were coming true.

Epstein Justice: When did you realize that your worst nightmares were coming true and not your dreams?

Juliette: The day I arrived in New York City, I was taken to an apartment building on East 66th Steet, and shown the apartment I would be staying in. As I was unpacking that day, I received a phone call from Sarah Kellen: She said we were flying to the Caribbean that day. I thought I was being flown to a model shoot.

Epstein Justice: Were you flown to a model shoot?

Juliette: Shortly after the airplane took off, Epstein started touching me between my legs. At that point, I felt utter terror. Everyone

on the plane saw how petrified I was and laughed. I thought, "Oh my God, I'm never going to see my family again." I had no way off the island, and I was sexually assaulted for two weeks. The last day on the island, I was summoned to Epstein's office. He told me that he worked for the CIA, and he had my family's name on a list. He said that one girl had accused him of rape, and he planted drugs in her apartment and had her sent to prison. Then he gave me \$300. I was very broken by the experience. Being kidnapped by people like that can really affect somebody.

Epstein Justice: How do you feel about the way the media has portrayed the plight of Epstein trafficking victims?

Juliette: The media has thrown the victims under the bus. I found it very difficult to get any help from the media. The media hasn't portrayed these people like the vicious, frightening monsters that they are. The BBC is only major media that has interviewed me. The BBC didn't mention that when I met Jeffrey Epstein he was traveling with Bill Clinton, and a number of other very important details about my plight. When I asked the producer why BBC had edited out important details, I was told that they were cut because they took away from the emotional impact of my interview, which I felt was not the truth.

Epstein Justice: How do you feel about the way the US government has covered up the crimes of Epstein and his cronies?

Juliette: Epstein and his cronies are very evil people. I feel lucky to be alive. I really don't know what to say about the government

#### covering their crimes. It's quite shocking. The world is so corrupt.

Epstein Justice: Do you think that Epstein Justice has the potential to make a difference in such a corrupt world?

Juliette: I'm grateful to Epstein Justice, because we really need justice in the Epstein case. We need to stand together. If enough people support Epstein Justice, I believe that there will be change.

# Person of Interest

## William Barr Part 1

The Justice Department under four presidential administrations – George W. Bush, Barack Obama, Donald Trump, and Joseph Biden – has failed to indict the perpetrators and procurers in Jeffrey Epstein's pedophile network.

But our newsletter's 2-part "Person of Interest" for this month and next month will focus on the illustrious former Attorney General William Barr, who served as attorney general under both George H.W. Bush and Donald Trump.

Shortly after Epstein's apparent suicide on August 10, 2019, <u>Barr pledged</u> that Epstein's child trafficking co-conspirators "should not rest easy." The Justice Department's investigation ostensibly proceeded through September, October, and November without a peep about Ghislaine Maxwell; then, finally, <u>"two law enforcement sources</u>" told Reuters that the FBI was investigating Maxwell at the end of December. But Reuters reported that the <u>"probe remains at an early stage."</u>



Though the Justice Department and FBI had law enforcement reports, reams of media reportage, and civil lawsuit documentation linking Maxwell to Epstein's child trafficking enterprise, it seems odd that the probe into Maxwell was at an early stage four-and-a-half months after Epstein's death, considering the severity of her crimes.

At long last, in March of 2021, Maxwell was finally charged with <u>child trafficking</u>. But Epstein and Maxwell's procurers, as reported by the <u>New York Times</u>, including Sarah Kellen, Leslie Groff, Adriana Ross, Nadia Marcinkova, etc., weren't indicted. And none of the perpetrators in the Epstein network weren't indicted either. So, despite Barr's vow that the Epstein network's co-conspirators not rest easy, none of them were indicted and their somnolence seems to have been unaffected by their crimes. Barr was en route to covering up the largest pedophile network ever acknowledged by law enforcement.

The American people had an ethical eunuch as their attorney general, but Barr didn't become a cover-up artist overnight. He had honed his coverup chops over decades. Barr grew up in New York City, and, during his formative years, his father, Donald, was the headmaster at Dalton School, one of the preeminent prep schools in the US. Prior to his employment at Dalton, Donald Barr served in the Office of Strategic Services, a forerunner to the CIA, and then he earned a PhD in English.

According to a July 15, 2019, article in the New York Times, <u>Donald Barr</u> resigned from Dalton at the end of school year in 1974, and Jeffrey Epstein was hired to start teaching at Dalton in September of 1974. Although Epstein was a college dropout, the prestigious school nonetheless hired him to teach math and physics. <u>The New York Times</u> article is uncertain whether or not Barr hired Epstein, but, according to a former Dalton teacher: "Barr didn't care about credentials as long as you were interesting and knew your stuff."

<u>Gardner Dunnan</u> replaced Barr as the Dalton headmaster, and a former Dalton student has since accused him of repeated sexual assaults when she attended Dalton. As Dunnan was at the helm of Dalton, Epstein developed a reputation for <u>"inappropriateness."</u> <u>A New York Times article</u>, published after Epstein's infamy, contained interviews of Dalton alumni. One of the alumni said Epstein's behavior among the girls attending Dalton was markedly different than the other teachers and didn't have very fond memories of Epstein: "She recalled observing Mr. Epstein flirting with the girls at the school, which drew her attention because it was so different than how other teachers behaved." Epstein was fired from Dalton in June of 1976, because his performance "didn't come up to snuff."

Interestingly, Donald Barr published his first novel, Space Relations: A Slightly Gothic Interplanetary Tale, when he was the headmaster of Dalton. Space Relations was a science fiction novel about a planet ruled by oligarchs who engage in child sex slavery. The novel graphically depicts the rape of a 15-year-old girl.

When Donald Barr was writing his novel about intergalactic child sex trafficking, Bill Barr graduated from Columbia University with a Bachelor of Arts in 1971 and went to work for the CIA. Barr was an official employee of the CIA from 1971 to 1977. As a CIA employee in Washington, DC, he attended George Washington University Law School.

In 1976, Barr wrote dossiers for CIA Director George H.W. Bush that were aimed at fending off congressional inquiries into the illegalities committed by the CIA. <u>The</u> <u>Village Voice</u> published a to a 1972 "Bill Barr: The 'Cover-Up General'" that stated: "...the experience was formative for Barr, turning him into an implacable enemy of congressional intrusions on executive prerogative."

Throughout the 1980s, Barr ricocheted between government service and a prestigious Washington law firm. In the wake of the 1988 election, Bush the Elder installed

Barr as a first assistant attorney general. In 1990, Barr became the deputy attorney general, which is the second most powerful position in the Justice Department.

Barr's boss at the Justice Department was Attorney General Richard Thornburgh, and the Department of Justice played an integral role in covering up the interstate pedophile network run Lawrence King of Omaha and Craig Spence of Washington, DC, which is discussed in The Franklin Scandal: A Story of Powerbrokers, Child Abuse, and Betrayal, written by Nick Bryant. Thornburgh was a very close friend of Craig Spence.

The "Franklin" child trafficking network was massive, and it required three hijacked grand juries to hermetically seal its cover-up: a state grand jury in Nebraska, a federal grand jury in Washington, DC. Thornburgh and Barr were at the helm of the Justice Department when their minions in Nebraska and Washington, DC perpetrated the egregious cover-up



### Person of merest William Barr Part 1

Though the phrase "grand jury" has authoritative connotations — like the gods of jurisprudence have issued a decree — the grand jury process has the potential to be seriously flawed. A grand jury makes the initial decision to indict (formally accuse) a criminal defendant to stand trial. But unlike a standard trial, a grand jury proceeding is cloaked in secrecy: grand juries aren't open to the public, and the identity of the witnesses who testify and the content of their testimony are never disclosed. The special prosecutor of a grand jury calls the witnesses, questions the witnesses, and selects the evidence that is shown to the grand jurors, and grand jurors are normal, everyday citizens who have shown up for jury duty and been funneled to a grand jury.

Generally, only witnesses and evidence deemed relevant by special prosecutors are presented to grand jurors, so special prosecutors are in a unique position to manipulate grand jurors' judgments. Indeed, commenting about the influence a special prosecutor has over grand jurors in 1985, Sol Wachtler, a former chief appellate judge of New York state, famously quipped that a special prosecutor could persuade grand jurors to "indict a ham sandwich."

For example, there was major corruption in the Florida state grand jury that investigated Jeffrey Epstein's crimes against children. Though the Palm Beach Police Department had the statements of five underage Epstein victims and was aware of many other underage victims, that grand jury's prosecutor Barry Krischer only called one of Epstein's victims to testify, and he skewered her. Consequently, that grand jury didn't indict Epstein on a single count of child abuse.

As a deputy attorney general, Barr also oversaw the collection of dirt on law professor Anita Hill when she accused Clarence Thomas of being a pervert and liar at his Supreme Court confirmation before the Senate Judiciary Committee. Hill had been a subordinate of Thomas when he headed the Equal Opportunity Commission, and Hill testified that Thomas was lewd, talked of bestiality, and kept abreast of porn stars.

However, very few Americans are aware that a second female subordinate of Thomas' had been subpoenaed to appear before the hearing who would have corroborated Anita Hill: Angela Wright had been employed by the Equal Opportunity Commission during Thomas' reign as chairman, and she, too, alleged lewd conduct and sexual harassment by Thomas.

Though Wright had flown from North Carolina to Washington to testify at the hearing, the Senate Judiciary Committee never called her. Senate Judiciary Committee Chairman Joseph Biden said Wright's subpoena had been lifted because of the wishes of Wright and her attorney. But Wright's attorney adamantly denied Biden's claim and stressed that Wright never asked for her subpoena to be lifted. In additional to Wright, three other women were willing to testify about Thomas' prurience and misogyny.

Thomas eked out a razor-thin majority in the US Senate—52 to 48-to become a Supreme Court justice. Barr and Biden had essentially worked in tandem to enable a depraved and probably compromised individual to become a Supreme Court justice.

Barr had definitely shown Bush the Elder, his former boss at the CIA, that he was a man who could be counted on for dirty deeds. So, when Attorney General Richard Thornburgh resigned to run for US senator in Pennsylvania in 1991, 41-year-old Barr was bumped up to attorney general.
