

A BYLAW CONCERNING OFFICIAL TRANSFER OF RESPONSIBILITY FOR THE CONTINUATION AND MAINTENANCE OF DRAINAGE WORKS CONSTRUCTED IN THE CENTRE MOOSE RANGE DRAINAGE DISTRICT NO. 24 FROM THE RURAL MUNICIPALITY OF NIPAWIN NO. 487 TO THE NIPAWIN CONSERVATION AND DEVELOPMENT AREA AUTHORITY UNDER THE PROVISIONS OF THE CONSERVATION AND DEVELOPMENT ACT, CHAPTER 203, R.S.S. 1953 AND AMENDMENTS THERETO

WHEREAS, with the establishment of the Nipawin Conservation and Development Area Number 101, the Nipawin Conservation and Development Area Authority assumed the responsibility for the continuation and maintenance of drainage works constructed in the Centre Moose Range Drainage District No. 24;

AND WHEREAS the transfer of the responsibility for the continuation and maintenance of the said drainage works has not been finalized officially by agreement as required under paragraph (a), of Sub-section (2) of Section 10 of the Conservation and Development Act, Chapter 203, R.S.S. 1953;

The Council of the Rural Municipality of Nipawin No. 487 enacts as follows:

The responsibility for the continuation and maintenance of drainage works constructed in the Centre Moose Range Drainage District No. 24, established March 1924, as shown on Plan No. D-11866-7 is hereby officially transferred to the Nipawin Conservation and Development Area Authority No. 101; and the Reeve and Secretary-Treasurer are hereby authorized to execute the attached agreement on behalf of the Rural Municipality of Nipawin No. 487 and to affix the corporate seal of the Municipality.

READ THREE TIMES BY UNANIMOUS VOTE and PASSED by the Council of the Rural Municipality of Nipawin No. 487, at Codette, in the Province of Saskatchewan, this day of June A.D. 1965.

MEMORANDUM OF AGREEMENT MADE THIS 12 DAY

OF June, 1961.

BETWEEN:

THE **NIPAWIN** CONSERVATION AND

the party of the first part)

THE RURAL MUNICIPALITY OF **NIPAWIN** NUMBER
487 (hereinafter referred to as the
party of the second part).

1. WHEREAS drainage works were constructed in the **Centre**
Moose Range Drainage District Number **24**
established **March 1924** in The Rural Municipality
of **Nipawin** Number **487** as shown on Plan
No. **D-11866-7** attached hereto.
2. AND WHEREAS in accordance with sections 36 and
37 of The Drainage District Act, chapter 314, R.S.S.
1953, the party of the second part is responsible
for the maintenance, keeping and repair of the said
works.
3. AND WHEREAS in accordance with paragraph (a) of
subsection (2) of section 10 of The Conservation and
Development Act, chapter 203, R.S.S. 1953, the party
of the first part may assume the responsibility for
the works by an agreement in writing with the party
of the second part.
4. AND WHEREAS pursuant to Bylaw No. 1-1965 dated
June 13/65 the party of the second part was authorized
to transfer the responsibility for the continuation
and maintenance of the said works to the party of the
first part, a copy of the said bylaw being attached
hereto.

5. AND WHEREAS Resolution No. 1 dated June 12/65 authorized the party of the first part to assume the responsibility for the continuation and maintenance of the said works by the party of the first part, a copy of the said bylaw being attached hereto.

IT IS HEREBY COVENANTED AND AGREED UPON between the two parties herein that for the consideration of One Dollar (\$1.00) and other valuable consideration the party of the first part shall assume the responsibility for the continuation and maintenance of the said works from the date and year first above written.
