

RURAL MUNICIPALITY OF NIPAWIN NO. 487

BYLAW NO 2-2014

A BYLAW TO PROVIDE FOR THE NUMBERING OF HOUSES AND OTHER BUILDINGS

The Council of the Rural Municipality of Nipawin No. 487 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be referred to as the Civic Addressing Bylaw.
2. This bylaw is intended to:
 - a) Identify areas within the R.M. of Nipawin where civic addresses on streets will be assigned and;
 - b) To assign those civic address to individual lots numbers and/or parcels as shown on the maps identified as Schedules "A" to "H", appended hereto and forming part of this bylaw.
3. All properties within the following sections of land locations will reference to the attached schedules with regards to their civic address on their street;
 - a) SE 7-49-14 W2, referred to as Pontrilas Subdivision – Schedule A
 - b) NE 7-50-15 W2, referred to as Smits Subdivision (Ferlon & Shelly) – Schedule B-1
 - c) SE 7-50-15-W2, referred to as Smits Subdivision (Marinus & Keli) – Schedule B-2
 - d) SE 3-51-14 W2, referred to as Youkan Subdivision – Schedule C
 - e) NW 3-51-14 W2, referred to as Klemmer Subdivision – Schedule D
 - f) SW 10-51-14 W2, referred to as Forest Edge Estates Subdivision – Schedule E-1
 - g) SW 10-51-14-W2, referred to as Bilous Subdivision – Schedule E-2
 - h) NE 27-51-13 W2, referred to as Station Acres Subdivision – Schedule F
 - i) SW 27-51-13 W2, referred to as Rolling Pines Subdivision – Schedule G
 - j) NW 3-52-13 W2, referred to as Gingara Subdivision – Schedule H

4. In case a house or building is occupied by more than one family dwelling unit or business, each separate front entrance of said house or building shall bear the same number extended with a letter of the alphabet beginning with the letter "A" and proceeding with as many as are required.

5. The Administrator shall be responsible for maintaining the numbering system and shall keep a record of all numbers assigned under this bylaw.

6. All existing numbers of houses and other buildings not now conforming to the provisions of this bylaw shall be changed to conform to the system herein adopted.

7. Bylaw No. 4-1984 is hereby repealed.
