**BYLAW NO 9-2016**

**A BYLAW TO PROVIDE FOR THE RURAL MUNICIPALITY OF NIPAWIN NO. 487 TO ENTER INTO AN AGREEMENT WITH THE RURAL MUNICIPALITY OF TORCH RIVER NO. 488 RESPECTING JOINT WEED MANAGEMENT COSTS**

The Council of the Rural Municipality of Nipawin No. 487 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be referred to as the Joint Weed Management Costs Agreement
2. The Rural Municipality of Nipawin No. 487 is hereby authorized to enter into an agreement with the Rural Municipality of Torch River No. 488 for the purpose(s) stated within the agreement.
3. The agreement is attached hereto and forms a part of this bylaw, and is identified as "Exhibit A".
4. The head of council and the administrator are hereby authorized to sign and execute the agreement described as Exhibit A.
5. It is understood and agreed that this Agreement shall be continuous, but may be terminated by either party by giving notice in writing to the other municipality, ninety (90) days prior to December 31<sup>st</sup> in any year.

THIS AGREEMENT MADE IN DUPLICATE this 8<sup>th</sup> day of July, 2016.

BETWEEN:

**RURAL MUNICIPALITY OF TORCH RIVER NO. 488**  
(hereinafter called "RM of Torch River")

AND

**RURAL MUNICIPALITY OF NIPAWIN NO. 487**  
(hereinafter called "RM of NIPAWIN")

WHEREAS:

The RM of Torch River and the RM of Nipawin undertake and agree that:

1. The RM of Torch River agrees to provide payment of Invoices pertaining to costs incurred regarding training expenses for the Weed inspector, i.e. registration, travel, meals, lodging.
2. The RM of Nipawin shall be invoiced for one (1) half the costs of above said expenses and agree to pay the RM of Torch River these amounts.
3. The RM of Torch River and The RM of Nipawin shall agree upon any expenses that will be shared prior to payment by both municipalities.
4. The RM of Torch River will charge The RM of Nipawin a rate of \$40.00 per hour for Weed application equipment. Chemical and Weed Inspector's time shall be the responsibility of each Respective Municipality.
