A BYLAW TO LICENSE AND REGULATE CONCERTS AND SPECIAL EVENTS Section 8 (1) (b) of the Municipalities Act

The Council of the Rural Municipality of Nipawin No. 487, in the Province of Saskatchewan, enacts as follows:

Short Title

 $\ddot{}$ This Bylaw may be referred to as the Concert and Special Events Bylaw

Definitions

- In this Bylaw:
- "Concert or special event" means any public or private event, gathering attendance of more than 50 people, including promoters, staff personnel and held indoors, outdoors, or a combination of both, that has an expected celebration, festival, competition, contest, exposition or similar type of activity, entertainers, but does not include:
- Any event on lands owned or controlled by the municipality that is either hosted by the municipality or has been authorized by the municipality pursuant to the terms of a lease, license or facility rental
- =: Any event on lands owned or controlled by a school board; or
- Ξï. accordance with a municipal zoning bylaw to allow for incidental Any event for which a development permit has been issued in gatherings or events as contemplated in the permit;

- d) "licence" means a licence issued by the administrator authorizing a concert special event to take place;
- e) "licensee" means a person named on a licence issued
- \dot{n} For the purposes of clause 2 a), a concert or special event is deemed to an expected attendance of more than 50 people when:
- It is to be held in a venue with an occupancy of more than 50 people;
- b It involves the printing or sale of more than 50 tickets or invitations; or

Power to refuse licence

Power to suspend or cancel licence

- Furnishes false information or misrepresents any fact or circumstance; or
- <u>b</u> Has contravened this bylaw whether or not the contravention has been prosecuted.

Conditions attached to licences

- 10. A licence is not transferrable.
- Every licence shall, at the licensee's expense and to the satisfaction of the municipality;

- f) Comply with any direction from the municipality to provide notice of the concert or special event to adjacent landowners; and
- Comply with all applicable federal, provincial and municipal laws.


Offences and Penalties

- 12. Any owner of land in the municipality who:
- a) Allows a concert or special event to be operated, maintained, conducted or for the concert or special event has been issued; or advertised on his or her land without ensuring that a valid and subsisting licence
- Allows a licensee to fail to comply with any terms or conditions set out in this bylaw;

bylaw of the municipality. Is guilty of an offense and liable on summary conviction as per the general penalty
