The Service Provider: Chinese Amazoner LLC

第一条 急速服务范围 Part I: Scope of Swift Services

本条款所涉及的全部内容仅对于中华亚马逊网站所提供的急速服务内容。所有急速服务内容和费用按照服务介绍解释为准。急速服务不属于中华亚马逊所接手的案件代理服务，其所涉及的任何律师服务仅限该服务内容，而非当事人代理律师服务。任何急速服务产生的相关政府费用均不属于中华亚马逊的职责范围，需要客户自行承担。

The scope of Swift Services only extend to the content provided by the website of Chinese Amazoner LLC. All Swift Services' content and quotations are based on the explanation of each service. Swift Services do not account to Chinese Amazoner LLC's represented cases, and any lawyer involved work only extend to the service content, and not to extend to the client's representation. All government fees associated with Swift Services are not obliged by Chinese Amazoner LLC, and ought to be covered by the client.

急速服务的服务时长按照该服务的解释为准。如有任何原因会导致服务延长，中华亚马逊会在服务时限完成前告知客户，并与客户商定处理。The duration of service for Swift Services is based on the explanation for each service provided. In case of a possible delay, Chinese Amazoner LLC will notify the client by the end of promised service duration and discuss possible solutions with the client.

第三条 咨询费用及支付方式 Part III: Service Quote and Method of Payments

中华亚马逊急速服务的客户可通过在线贝宝信用卡支付服务款项，所有的急速服务款项都应在服务开始前付清。如需要其它支付方式，客户可与中华亚马逊客服联系通过电子汇款，银行存入支票，Zelle 或等值人民币支付款项。Clients of Chinese Amazoner Swift Services can pay services online using credit cards via PayPal. All Swift service amount due should be paid prior to the start of the service. If other methods of payment are needed, the client can contact Chinese Amazoner LLC customer services to pay with Zelle, wire transfer, electronic check payment or Chinese Yuan of the same value.

第四条 咨询项目工作要求 Part IV: Terms of Services



1. 为保证本项目的顺利进行，甲方应确定 1 位主要联系人，负责甲方和乙方咨询顾问进行项目日常工作的接洽与沟通。For the best result of this service, the seller will appoint one client specialist for routine service communication.
2. 甲方在工作过程中会要求乙方配合提供有关资料。如乙方无法提供部分资料，应与甲方进行沟通，协商解决的办法。如乙方拒绝提供必要信息，甲方有权终止服务，并保留乙方已支付的费用抵偿服务经费。The seller will occasionally request relevant documents from the buyer. In cases that some documents are not available, the buyer should work with the seller for the best solutions. In cases that any crucial information request is denied by the buyer, the seller has the right to terminate the service without refunding any fee prior to the point for service cost.
3. 本合同中提及的大多数移民局申请都是需要政府所收申请费用的，具体金额以美国移民局官网最新更新为准。本合同中提及的法律费用与移民局申请费用需要乙方一同承担。Most of the USCIS petitions mentioned in this agreement are subjected to government charged service fees according to USCIS official website. The legal fee mentioned in this agreement and USCIS service fees are concurrently obliged by the buyer.

第五条 服务终止条款 Part V: Terms for Service Termination



- 情况 1: 如乙方因个人原因主动放弃申请, 甲方将有责代表乙方向移民局提出终止申请, 并有权保留当前所有乙方已支付的服务费用。 Scenario 2: If the buyer voluntarily withdraws the application, the seller is obliged to send a formal withdrawal request to USCIS on behalf of the buyer. The seller then has the right to keep any payment up to the point for service cost.
- 情况 2: 如出现不可抗力造成申请无法顺利进行, (例如: 疫情移民局暂停工作等原因) 甲方将在不可抗力失效后即刻继续为乙方进行申请。 Scenario 3: In cases of an unpredictable force that obstacles the process of application, (e.g., Covid quarantine affected USCIS work schedule) the seller should resume the buyer' s application as soon as the unpredictable force no longer obstacles the application.
