IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

Before me, the undersigned Assistant District Attorney of Harris County, Texas this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **LEON PHILIP JACOB**, hereafter styled the Defendant, heretofore on or about **JANUARY 12, 2017**, did then and there unlawfully intentionally and knowingly cause bodily injury to [REDACTED] a PERSON WITH WHOM THE DEFENDANT HAD A DATING RELATIONSHIP, hereafter styled the Complainant by APPLYING PRESSURE TO THE COMPLAINANT'S FACE WITH HIS HAND.

PROBABLE CAUSE

Affiant, Carlton Jack, is a certified peace officer employed with the Houston Police Department as an investigator in the Special Victims Division. Affiant has reason to believe and does believe that Leon Philip Jacob, hereafter styled the defendant, committed the Misdemeanor offense of Assault Family Violence in Harris County, Texas on or about January 12, 2017. Affiant bases his belief on the following facts: Affiant spoke to [REDACTED] a person affiant found credible and reliable, and hereafter styled the Complainant. Complainant told affiant that on January 12, 2017 at 5151 Edloe Street # 11401 Houston, Harris County, Texas the defendant, who she knows by name and sight as her boyfriend, assaulted her causing pain and injury. The Complainant told affiant that she came home from work and the defendant became upset and stated "He was tired of her attitude and pissy face" and began yelling at Complainant saying "He was not putting up with her shit". Complainant told affiant she left her residence to remove herself from the situation and she received a telephone call from defendant apologizing so she returned back to her residence. Complainant told affiant shortly after returning home, defendant began yelling and throwing dishes into the cupboards. Complainant told affiant she walked away from defendant and the defendant followed her into the bath room and began throwing her personal items around saying his family will "ruin her." Complainant stated she began to scream and the defendant then grabbed her face with his hands and applied pressure busting her upper lip causing her pain. The defendant stated "Shut up you dumb cunt" at which time Complainant told affiant she bit the defendant's hand to get him to release her. Affiant interviewed defendant in a recorded noncustodial voluntary interview wherein he told affiant he and Complainant got into an argument when she was screaming and throwing things around the apartment and at him. Defendant admitted that he placed his hand over the Complainant's mouth to get her to stop screaming stating "Sweet heart stop yelling" when Complainant bit his hand and her lip. Defendant told affiant. "I don't think it was a good ideal to put my hand over her mouth."
