**WHEREAS,** the Village of Lewiston originally adopted a Local Waterfront Revitalization Program in 1989 and subsequently amended the program in 2011; and

**WHEREAS,** acknowledging the need to update the LWRP to reflect current conditions and to help better manage land use activities in the Village, the Village Board of Trustees authorized the preparation of an update to the local program; and

**WHEREAS,** the Village of Lewiston Board of Trustees, assisted by the Lewiston Waterfront Advisory Committee and GHD Engineering, have completed a Draft Amendment to the LWRP in accordance with New York State Department of State guidelines; and

**WHEREAS,** the adoption of an update to the LWRP is a Type 1 action under the State Environmental Quality Review Act (SEQRA); and

**WHEREAS,** in accordance with SEQRA, the Board of Trustees as Lead Agency, conducted a coordinated environmental review of the LWRP amendment, and has received no substantial comments from any interested and involved agencies; and

**WHEREAS**, the findings of the environmental review indicate that the adoption of the Village of Lewiston LWRP Amendment will not adversely affect natural resources, public health, safety and welfare, and is consistent with community considerations.

**NOW THEREFORE BE IT RESOLVED,** that the Village of Lewiston Board of Trustees, acting as lead agency, has determined that the adoption of the LWRP Amendment is not anticipated to result in any significant adverse impacts on the environment and that a Negative Declaration is hereby issued.
