#### **DISCUSSION**

# **Pavilion at Lewiston Landing**

Mayor Welch said she would like to ask for grant funding from the Greenway Commission for the construction of a pavilion at Lewiston Landing, to replace the prior-existing pavilion at this location. This would measure 20 x 30 and cost around \$200,000 to construct.

A motion was made by Deputy Mayor Eydt seconded by Trustee Fittante and passed unanimously to send a letter to the Town of Lewiston, our host community, for feedback and support to request funds from the Greenway Commission for the construction of a pavilion at Lewiston Landing.

### **Lewiston Landing Boat Launch**

Frank Campbell of Destination Niagara spoke on the economic impact of the fishing industry in the area, and addressed concerns about the waterfront. Campbell suggested extending the Harbor Master's season to extend further into the 'shoulder season', as that is the busiest time at the waterfront. Campbell said this is a world class fishery, and I want to maintain what we already have. Additional concerns about the ice boom were addressed; Superintendent Mang said he would speak with the contractor regarding these concerns.

Mayor Welch said that we are spending a lot of money to make the waterfront and fishing amenities better. The work on the fish cleaning station, bathrooms and stairs are projected for completion by April 1, 2025.
