NEW BUSINESS A) APPLICATION FOR CERTIFICATE OF APPROPRIATENESS

2017-18 **424 PLAIN STREET** A discussion ensued surrounding the installation of divided lite windows. A motion to grant the certificate of appropriateness was made by Jim Fittante, seconded by Rita Geiben and

passed unanimously with the following conditions:

A total of 9 windows shall be replaced. All windows shall be wood inside, and vinyl clad outside. 3 street facing windows and 2 east side windows shall be replaced with divided lite windows in order to preserve the homes

original appearance from the street front.

B) APPLICATION FOR CERTIFICATE OF APPROPRIATENESS 2018-10 **470 RIDGE STREET** A motion was made by Chairman Slaugenhoupt to remove 470 Ridge Street from Historic Designation.
