WHEREAS, the Village Board of Trustees, as lead agency, has prepared and evaluated an Environmental Assessment Form concerning the action of adopting the LWRP in accordance with the requirements of the State Environmental Quality Review Act and Part 617 of the implementing regulations of Article 8 of the New York State Environmental Conservation Law

NOW, THEREFORE, BE IT RESOLVED,
That the Draft Local Waterfront Revitalization Program for the Village of Lewiston is accepted by the Village Board of Trustees as complete and ready for public review, and shall be submitted to the New York State Department of State for review by regional, State and Federal agencies, pursuant to the provisions of Article 42 of the New York State Executive Law.
