HEARINGS Mayor Welch opened the public hearing at 6:04pm with the Pledge of Allegiance on the adoption of the 2021-22 proposed budget.

No residents spoke on this topic; A motion was made by Trustee Gibson seconded by Trustee Conde and passed unanimously to close the public hearing at 6:05pm.

Amend Local Law 2021-1

Mayor Welch opened the public hearing at 6:05pm to amend Local Law 2021-01 – Flood Damage Prevention; to include the Village of Lewiston Municipal Building address as the location of the map repository to include the location for the flood maps.

No residents spoke on this topic; A motion was made by Trustee Conde seconded by Trustee Marasco and passed unanimously to close the public hearing at 6:06pm.

Adoption of Five-Center Water Rate Increase

Mayor Welch opened the public hearing at 6:06pm to adopt the proposed fivecent water rate increase from \$3.70 to \$3.75 per 100 cubic feet of water consumed, effective for the July 1, 2021 billing cycle.

No residents spoke on this topic; A motion was made by Trustee Gibson seconded by Trustee Eydt and passed unanimously to close the public hearing at 6:07pm.

- **CALL TO** Mayor Welch called the meeting to order at 6:07pm. **ORDER**
- **RESIDENTS Barbara Kivi** presented a plan to the board to rezone the property, 155 South 5th Street, to allow for retail business. Kivi stated that there are commercial spaces surrounding the property, and that she has a buyer interested in purchasing the space to fix up and utilize for retail. Kivi also stated that the historical integrity of the home would not be effected.

Building Inspector/Zoning Officer Candella suggested that a special use permit be submitted instead of rezoning the property.

Mayor Welch stated that rezoning this property would be spot zoning, and not something the board would do. Welch stated that if they would like to apply for a special use permit, a public hearing would need to be held, where a proposal and business plan, including additional parking, would need to be presented to the Historic Preservation Commission, Planning Commission and Village Board. It was also mentioned that a special use permit would need to be reapplied for annually.

Resident, owner of 625 Oxbow Lane, expressed his concern for the need for a stop sign at the corner of Oxbow and West Lane. He stated that there are many children in this area, and feels that this would slow down the traffic between N. Fifth to N. Eighth Street.

Mayor Welch stated that she will contact Chief Previte on this matter for him to review the area.

Trustee Eydt added that a public hearing would need to be held after listening to the recommendations from Chief Previte.

MINUTES A motion was made by Trustee Eydt and seconded by Trustee Conde to approve the minutes from the Village Board Meetings held on March 15, 2021 and April

5, 2021 and the minutes from the Budget Meetings held on March 22, 2021 and March 29, 2021. The board meeting minutes passed unanimously. Trustee Marasco voted no to the budget meeting minutes, which passed with four yes votes.

We will be doing the annual basket auction during the event, and I have reached out to many local businesses for donations; all proceeds will go towards the Marilyn Toohey All-Inclusive Playground. We will also be doing our one-mile fun run, with security escorts from the fire and police department.

DISCUSSION

Hennepin Park – Reserved Parking Request

A discussion ensued regarding a request for reserved parking on S. 4th Street side of Hennepin Park during a wedding on August 7, 2021. It was decided that not enough information was given to determine what would be permissible. Clerk Fundis said she would reach out to them again and request more details on the length of time and how much parking is being requested.

Fencing Along Center Street

Mayor Welch discussed the need for the deteriorating fences throughout the village to be replaced. Welch stated that many are falling apart, and that she would like to switch to a vinyl option. The existing wood is a maintenance nightmare for the Department of Public Works.

Susan Hofert, a village resident and member of the Historic Preservation Commission, stated that she would love to preserve the look of the white picket fences throughout the village, and thinks it is a great idea to look towards replacing with a commercial grade vinyl or a product more sustainable.

Welch asked Hofert if she would discuss this with the Historic Preservation Commission and asked Treasurer Myers to add this discussion to the agenda for their upcoming meeting.

REPORTS Treasurer Myers discussed the additional services the Clerk's office will be retaining with the existing payroll company to ensure that the village is in compliance and all necessary documents are up to date. They will also be handling annual training requirements for all employees and keeping everyone up to date on trainings and certifications.

Superintendent Wills wanted to remind the residents that at this time they are required to bag the leaves and grass and put out to the street on their regularly scheduled garbage pickup day; we do not pick the un-bagged leaves up with the truck until around or after Halloween. Wills added that the ice boom is almost out, and the water and power are on at Lewiston Landing; most boat slips will be ready by May 1, 2021.

BOARD Trustee Eydt mentioned that there would be another meeting on Monday, April 26, 2021 at 6pm. on the village water infrastructure and adding another line for an additional water source into the village.

Trustee Marasco discussed her work weeding, pruning and planting around the Chamber of Commerce, the Circle and the Peace Garden. I also have been helping the Garden Club and just want to say I appreciate all that you do.

Mayor Welch said she had the pleasure of walking with some members of the Garden Club for a few hours on Sunday and we mapped out where the planters and pots will be placed. I am glad that I was to be a part of this.
