**CALL TO** Mayor Welch called the Village Board of Trustees meeting to order with the

**MINUTES** A motion was made by Trustee Gibson seconded by Trustee Marasco and passed

unanimously to approve the February 16, 2021 Village Board Meeting and

March 1, 2021 Work Session minutes.

**REPORTS** Recreation Director McDermott reported that he had successfully passed the National Recreation & Parks Association (NRPA) Certified Park and Recreation

Professional (CPRP) certification exam this month.

McDermott mentioned that on Saturday, April 3, 2021 from 12-2 pm at the Red Brick, kids can come and have a picture taken with the Easter Bunny and will receive treats and a craft. This event is free but requires pre-registration by April 2, 2021.

The Village of Lewiston Recreation Department, Town of Lewiston Recreation Department and Village of Youngstown are teaming up to run a virtual Fishing Derby which will begin July 18<sup>th</sup> and run through August 22<sup>nd</sup>.

**Historian Piper** reported that he has been refreshing the walls in the hallway of the Red Brick with pictures and it is coming together nicely.

LIAISON REPORTS **Trustee Marasco** reported that the Jazz Festival has been cancelled for 2021 due to lack of funding. The Jazz Festival Board will get together and talk about having a smaller venue this year and maybe turn that into a fundraiser for Jazz Fest year,

2022.

OLD BUSINESS **Trustee Gibson** addressed the request for 1 or 2 parking signs in front of The Plant Shack at 335 Center Street. #### **Boy Scouts of America Troop 855 Place Flags on Center Street**

A motion was made by Trustee Marasco seconded by Trustee Gibson and passed unanimously to approve the request made by Boy Scouts of America Troop 855 to hang flags at the intersections on Center Street from 4<sup>th</sup> to 9<sup>th</sup> Street to be in place for Memorial Day Weekend. The total cost is \$284.56 which Treasurer Myers stated has been budgeted for.

Letter of Support to Town of Lewiston Adopting the Policing Reform Plan

A motion was made by Trustee Eydt seconded by Trustee Marasco and passed unanimously to send a letter to the Town of Lewiston Supervisor and Councilmen in support of the Town of Lewiston's resolution adopting the Policing Reform Plan in compliance with Governor's Cuomo's New York State Police Reform and Reinvention Collaborative under Executive Order 203.

### **REPORTS**

**Deputy Clerk Vazquez** reported the Clerk's Office has been working with the Department of Public Works making appointments to get the remaining 23 residents water meter heads changed out.

**Treasurer Myers** gave an example of the new water bill showing the bill is estimated and there is a \$50 fee for manual read until they get the new water meter head in place.

**Law Counsel Leone** stated that he received a stipulation to discontinue without cost to either side in reference to the lawsuit for Stephanie L. Hurst and Rhylan C. Hurst vs. The Village of Lewiston in regards to a sledding accident that happened at the Reservoir State Park.

# BOARD REPORT

**Trustee Eydt** gave an update on the meeting he had with Engineer Marino, Trustee Conde, Lewiston Fire Co. #1, and Superintendent Wills in regards to the water coming into the Village. They discussed plans to bring another line across the parkway off NY 104 which will boost the water pressure and give us a second source of water. They are working on getting the funds and will meet in April to look at the first set of plans.

**Mayor Welch** stated she had a Zoom Meeting this morning about the Bike Trail Signs to go along Cayuga Street. Welch stated the signs will be minimal and small in size.

Mayor Welch met with Bill Paladino in regards to the Frontier House. Paladino stated he would be back in April with the plans, and that construction is resuming at 8<sup>th</sup> and Center Street.

Mayor Welch reported she had a meeting with Town of Lewiston Supervisor Broderick, Councilman Jacobs, Attorney Bax, Trustee Eydt, and Law Counsel Leone to discuss putting a Police Contract in place.
