# VILLAGE OF LEWISTON PRIVILEGE OF THE FLOOR - RULES OF PROCEDURE

- 1) Public participation is a privilege and an opportunity to address the Board on matters of general interest affecting the Village of Lewiston.
- 2) These rules are established to ensure for orderly participation.
- 3) Only one person may speak at a time.
- 4) Speaker should stand if able and give name and address.
- 5) All comments shall be directed only to the Village Board as a whole and not to any single member thereof.
- 6) Speaker should keep comments to 5 minutes or less and will only be allowed to speak one time.
- 7) Speaker must stay on topic and speak to issues of general interest to the Village such as comments on Village policies, finances, procedures, etc. If speaker has a specific problem, please contact the Village during working hours at the Village Hall.
- 8) This is the Board's opportunity to listen to speaker's concerns and comments but not for speaker to engage in back and forth with the Board. Any questions the speaker has may be stated. If the Board so chooses, the Board may address questions after the close of public comments.
- 9) If comments are made from the floor, or if any speaker uses inappropriate language or becomes abusive or unruly, or personally attacks any person, speaker will be cut off and may not be recognized in the future for public participation.
- 10) If any individual persists with disruptive behavior and/or continues to fail to follow the rules stated herein, the Mayor may order that person to leave.
