## **CODE OF CONDUCT**



To promote safety and comfort for all, we ask individuals to act appropriately at all times when they are in our facility or participating in our programs. We expect persons using the Saratoga Regional YMCA to behave in a mature and responsible way and to respect the rights and dignity of others. Our Code of Conduct does not permit language or any action that can hurt or frighten another person or that falls below a generally accepted standard of conduct.

Specifically, this includes, but is not limited to:

- Appropriate attire must be worn at all times. Offensive wording on shirts or accessories is inappropriate.
- We do not tolerate harassment or intimidation by words, gestures, and body language or any other menacing behavior.
- Angry or vulgar language including swearing, name calling or shouting.
- Unwarranted, Unwanted physical contact with another person in any angry, inappropriate, or threatening way is not permitted.
- Theft or behavior which results in the destruction of property is not permitted.
- Using or possessing illegal drugs or alcohol while in or on YMCA property is not permitted.
- Loitering is not permitted in or outside the YMCA.
- No firearms, shotguns or rifles are permitted on SRYMCA premises.
- The demonstration of any sexual activity or engaging in sexual conduct with another person is not permitted.
- Any conduct that is inappropriate, threatening or offensive in nature i.e. interrupting fitness classes or structured workouts.

Food is not permitted in fitness areas; only sealed plastic bottles are permitted.

The Saratoga Regional YMCA is a tobacco-free environment. Use of tobacco products is not allowed on our property, including electronic cigarettes.

Members who are listed as registered sex offenders will have their membership terminated. We screen all members and visitors upon their first entrance through

a national sexual predator database in conjunction with the Background Bureau Investigation and Raptor Technology Services. We reserve the right to do background checks on members on a continued basis.

Members and guests are encouraged to be responsible for their personal comfort and safety. A member or guest who feels unsafe or uncomfortable should report the situation to a staff person.

Video recorders, cameras or any other visual recording devices are not allowed within the Saratoga Regional YMCA without prior written permission of the CEO.

A parent, guardian or other adult member must accompany any child under the age of 10 while they are in the facility, including the pool.

All reported incidents will be reviewed by the Executive Director of the Branch. If a violation of the Code of Conduct has occurred, the decision to suspend or terminate YMCA membership privileges will be made at the discretion of the Membership and Programs Executive or the Vice President of Operations.

The Saratoga Regional YMCA is not responsible for any lost or stolen items.

## PARENT OR GUARDIANS (AGE 18 + YEARS) OF CHILDREN UNDER 10 YEARS OF AGE:

The Saratoga Regional YMCA has a policy that for everyone's safety, children under the age of 10 cannot be left unattended in any area of the YMCA. Parents/guardians must be present with children under the age of 10 at all times including YMCA staff led instructional programs. I understand that I am required to stay with my child (if under the age of 10 years old) while the program is in session.

## **ALL PARTICIPANTS OR THEIR GUARDIANS:**

In consideration for being allowed to participate in any of the YMCA exercise programs and clinics, I agree to assume the risk of such exercise, and further agree to hold harmless the YMCA and its staff members conducting the exercise program from any and all claims, suits, losses, or related causes of action for damage, including, but not limited to, such claims that may result from my injury or death, accidental or otherwise, during, or arising in any way from, the exercise program.
