Meeting the Qualifications

- b. Copies of the last three months bank statements (all pages).
- 4. Copy of your Valid Driver's License issued by a state or outlying possession of the United States.

If Applicable

- 1. Proof of SSI / Disability.
- 2. Proof of Child Support.
- 3. Proof of Pension or Retirement income.
- 4. Proof of Rental income (copies of Rental Agreements).
- 5. Proof of Section 8 Housing Assistance/ Veteran's Voucher

Once we have 'pre-approved' your application; it will be sent to the owner of the property for 'final approval'.

4. **Employment Verification:** Some companies utilize a third-party company to handle their employment verifications. These third-party companies charge a fee to anyone seeking an employment verification. If your employer utilizes one of these companies; you will be responsible to reimburse Shady View Apartments the fee charged.

5. Qualifying to rent.

- a. Your "Gross" rent must be greater than 3 times of the monthly rent.

6. Security Deposit.
