Additions to agenda: Consider another board member for Housing Finance Committee, added to new business. Motioned by McNeff to approve the agenda with additions, seconded by Burgard, motion carried.

Motioned by Brattvet to approve the June 28, 2018 minutes, seconded by Feickert, motion carried. Housing Finance Committee Special Meeting minutes for June 28, 2018 are being looked over by Attorney Bill Hartl.

Motioned by Kraft to approve the July 16, 2018 special meeting minutes, seconded by McNeff, motion carried.

Bills and financials were reviewed. A motion to approve the bills and financials as reported was made by Schaan, seconded by Hoffert, motion carried.

Highlights from Directors Report: Brossart went to Souris Basin Planning Council Comprehensive Economic Development Strategy Input Meeting in Towner on July 25 from 10am to noon. Follow up to this input meeting is in Minot on Thurs, Aug 30. JDA board members, city council members, etc are encouraged to attend.

#### Old Business:

- a. Chalmers Addition Lot 2, Block 2 is sold.
- Pizza oven was on bids for 2 weeks in Tribune with special meeting being held Mon, July 16 at 12:00PM to open the sealed bids – Roughrider Pizza bid was accepted.
- Pierce County Recorder filing was finalized for satisfaction of lien from 2013 for North Central Correctional & Rehabilitation Center. (Was not previously filed.)

#### **New Business:**

- Daunne Heilman has resigned from the JDA Board. Motion to accept resignation by Feickert, seconded by Hoffert. Motion carried.
- b. Consideration of another board member for Daunne's position as Vice President. Burgard nominated St.Michel who was absent, seconded by McNeff. Motion to cease nominations

- by Hoffert, seconded by Schaan, motion carried. Tabled until next meeting to see if StMichel will accept VP position.
- c. Consideration of another board member for Daunne's position on the Housing Finance Committee. Brattvet said that he would consider the position. Burgard motioned to nominate Brattvet for committee position, seconded by Schaan. Motion to cease nominations and cast unanimous ballot by Hoffert, seconded by McNeff, motion carried.
- d. Consideration of the 2019 budget. Only 2 updates were made (noted on budget) from the City of Rugby's information. After discussion, motion to approve proposed 2019 budget by Schaan, seconded by Brattvet, motion carried.
- e. Poll was conducted through email of Rugby businesses, & the JDA Facebook page & website. Poll results revealed that participants are 68.4% in favor of the JDA, CVB, & Chamber combining resources. If a collaboration does happen, the poll revealed a 50/50 response to wanting the location to be on Highway 2 or downtown.

Brossart shared how she had no preference with staying in current office, being located on the highway, or being downtown. She wants what is best for the JDA & everyone involved.

David Bednarz, city council, shared his views from being on the Museum board. Collaboration location ideas were shared from members of the board with many ideas that can be researched further. After much discussion, McNeff motioned to seek space & collaboration opportunities, seconded by Schaan, motion carried. Steinke abstained from vote.

Steinke motioned that the JDA should coordinate a JDA Think Tank for ND towns with populations under 5000 here in Rugby, seconded by McNeff, motion carried.
