



Tech Endorsement Agreement

This Endorsement Agreement ("Agreement") is between Rotosound Manufacturing Limited ("Rotosound") and the backline technician ("Tech").

WHEREAS, Rotosound is a business duly organised, validly existing, and in good standing under the laws of the United Kingdom. Rotosound has its principal office and place of business at Unit 3B, Morewood Close, Sevenoaks, Kent, TN13 2HU, United Kingdom.

WHEREAS, Tech is a professional guitar, bass, or backline tech whose endorsement and services have commercial value to Rotosound.

WHEREAS, Rotosound is desirous to obtain the right to use the name, likeness, and endorsement of an artist in connection with the Tech for advertisement and promotion of the products of Rotosound, namely the artist or Tech's preferred choice of instrument string.

NOW THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Tech and Rotosound agree as follows:

APPOINTMENT. Rotosound would like the Tech's assistance in promoting Rotosound's products. Rotosound hereby appoints the Tech as its representative on a non-exclusive, non-employee basis to endorse Rotosound's products and its brand to clients.

TERM. This Agreement may be terminated by either party upon 60 days prior written notice to the other party.

SERVICES. In connection with the appointment, the Tech agrees to the following:

- I. That the Tech hereby authorises and grants to Rotosound the right, license and interest to use the Endorsement in respect of the marketing, promotion, advertising and sale of the product;
 - a. That the Tech will provide Rotosound with quotations which can be used for the marketing, promotion, advertising and sale of the product.
 - b. That the Tech will provide Rotosound with at least one high-resolution photograph (at least 1000px by 1000px) which can be used for the marketing, promotion, advertising and sale of the product.
 - c. If an appropriate scenario arises, that Rotosound may film or photograph the Tech using the product. An example of this would be at a concert. This content would then fall under the rights and licence of "Services section I".

CONFIDENTIALITY. Each party agrees that it will not disclose to any third party or use any Confidential Information disclosed to it by the other party except as expressly permitted in this Agreement; and that it will take all reasonable measures to maintain the confidentiality of all Confidential Information of the other party in its possession or control, which will in no event be less than the measures it uses to maintain the confidentiality of its own information of similar importance.

COMPENSATION. In exchange for the Tech's performance of its responsibilities, Rotosound agrees to provide products to the Tech at a reduced rate. The "Artist Rate" for the product will be provided to the Tech upon request.

DISPUTES. Any controversies or disputes arising out of or relating to this Agreement shall be resolved by contacting the other party. All documents, materials, and information in the possession of each party that are in any way relevant to the dispute shall be made available to the other party for review and copying. Amended contracts will then be issued.

SIGNATORIES. This Agreement shall be deemed signed on receipt of an email confirmation from the Tech and will be effective as of the date for the confirmation email.
