2. DELIVERY AND INSTALLATION TERMS

Site Preparation: The Buyer is responsible for ensuring the site is prepared for home delivery, including foundational work, utilities, and permits, unless otherwise agreed.

Installation: The Seller agrees to install the home by backing in onto the prepared site. If the site does not allow for free movement of the truck, any additional equipment required would be at the Buyer's expense.

3. TRANSFER OF TITLE AND RISK

Ownership and risk of loss or damage to the Modular Home shall pass to the Buyer upon Final Payment.

4. INSPECTION AND ACCEPTANCE

The Buyer has the right to inspect the Modular Homes upon delivery and installation and must notify the Seller of any defects within 10 days. Failure to provide such notice will be deemed as acceptance of the Modular Homes.

5. WARRANTY

The Seller (Lykke Enterprises Inc.) does not provide a direct warranty. However, the Modular Home is covered under the manufacturer's warranty provided by Shelter Homes Inc., and Progressive Home Warranty.

Mandatory warranty coverage - ALBERTA

- 1-year: Defects in materials and labor for items like flooring, paint, and fixtures.
- 2-year: Defects in distribution systems, including plumbing, electrical, and heating systems.
- 5-year: Defects in the building envelope, such as the exterior walls, roof, and windows.
- **10-year:** Major structural defects that affect load-bearing parts of the home, such as the foundation, beams, and trusses.
