Job Description:

The District Conservation Planner will plan and implement conservation and educational programs. They should be familiar with production agriculture, natural resource concerns in farming, and urban stormwater management. Required skills include general GIS knowledge, keen observation, strong analytical abilities, and excellent communication and writing proficiency. The candidate will be required to attain Level III Conservation Planner status through training provided by the Natural Resources Conservation Service. The candidate can expect occasional outdoor field work, afterhours work related to board meetings, special events and training. The selected candidate must have a valid driver's license and be required to get fingerprinted and complete a federal government background check.
