**NRI 746- Coltonville Solar Farm LLC-** Director Martz moved to approve NRI 746 Coltonville Solar Farm LLC. with the recommendations provided in the opinion page of the report. Director Zurbrugg seconded the motion, motion carried.

**Approve CPA for SWCD Financial Review-** Director Zurbrugg moved to approve Foster Tax and Accounting LLC to complete the annual financial review and Comptrollers Report. Director Kenney seconded the motion, motion carried.

SWCD County Roadside Signs- A new bill passed by the General Assembly allows for SWCD road signs identifying that you are entering the Soil and Water Conservation District to be placed on the county lines. The sign will be placed by the Illinois Department of Transportation on State highways entering the county at a cost of \$100 per sign and will be maintained by IDOT. The board questioned if there could be logos or QR code placed on the signs. At this time no answer was available, and the Executive Director agreed to follow up with the AISWCD to get more information. The topic was tabled until the next meeting.

**SWCD Budget Meeting Date-** The annual budget is due to be reviewed by the board by the end of June. A tentative date of June 24<sup>th</sup> was set, the Executive Director will follow up with Directors to firm up a time for that meeting.

AISWCD Summer Conference- The board was reminded of the Annual Meeting in Springfield. It was the consensus of the board that Director Kuhn would serve as the delegate representing DeKalb County SWCD at the meeting. The board also reviewed the resolutions being proposed but no action was taken at the district meeting, the board will leave it up to the discretion of the delegate at the annual meeting on what action to take once a resolution comes to the floor.
