The SWCD Staff will have **30** days from receipt of the application and fee to conduct a review of the Annual Monitoring and Maintenance Report and submit comments. The DeKalb County Community Development Department and applicant will be notified when the report has been approved by the DeKalb County SWCD. Copies will be maintained in the Districts files.

The Monitoring and Maintenance Report shall be prepared by an ecologist and shall include, at a minimum:

- ✓ Project name and geographic location;
- ✓ Map location and description of each plant community present on-site;
- Description of the general condition of each plant community including any issues or deficiencies from the performance standards*;
- List of all species observed in each plant community, including scientific and common names, based on a minimum of two
 (2) meander searches conducted by an ecologist during the growing season (one (1) meander search in the spring and one (1) in the summer);
- List of five (5) most dominant species present in each community, estimated based on visual observation during the meander searches, including scientific and common names;
- ✓ Discussion of maintenance activities implemented during the current year being reported on;
- ✓ Summary of maintenance activities planned for the coming year, including any "adaptive management" strategies proposed to address issues or to correct deficiencies from the performance standards; and
- ✓ Color photos representing each plant community and their general condition including any issues observed or deficiencies in performance standards.
