### INFORMATION TO APPLICANTS APPLYING FOR MEMBERSHIP

#### Brief History

Some years ago, Mrs. Helen Webb Harris had a dream. On April 22, 1937, that dream became a reality when the WAKE-ROBIN GOLF CLUB was organized with thirteen members. It is the earliest founded black women's golf club in the United States. The name WAKE-ROBIN is derived from a spring flower.

The purpose of the WAKE-ROBIN GOLF CLUB at its inception was to introduce black women to, and provide the vehicle for, competitive participation in golf, which was a major challenge in 1937. Opportunities for blacks to participate in local and national events were non-existent. Through the years, hundreds of women have chosen to affiliate with the Club. The WAKE-ROBIN GOLF CLUB has set an exemplary record in golfing activities in order to achieve its objectives.

#### Our Mission

The Club exists to foster and perpetuate women's interest in golf and encourage women in Washington, D.C. and vicinity to become golfers. We are the premier force for promoting and advancing women's interest in golf. WAKE-ROBIN GOLF CLUB is a 501 c (3) organization. Funds raised by the club through tournaments and golf related activities help the club support other organizations in need and offer scholarship support.

#### Admission Procedures

The membership of the Club shall be open to all women who are interested in playing golf and whose applications is completed, who are recommended by the Membership Committee and voted on by the general membership body and for whom all fees are paid.

1. A person or persons applying for membership will submit an application form accompanied by the non-refundable application fee to the membership chairperson
2. A person or persons applying for membership will serve a probationary period of one year. During this probationary period the new member must attend at three (3) of the five (5) meetings held by the Club each year. In addition, person (s) applying for membership in lieu of an established handicap will during their one year probationary period submit a minimum of ten eighteen (18) hole or twenty (20) hole score cards. At least five (5) 18-hole score cards will be attested to by a Wake-Robin member. If the conditions of this probationary period (one year) are not met the probationary period shall be reviewed by the Club and may or may not be extended and regular membership shall be extended or denied.
3. All new members will be given an orientation by a member(s) of the membership committee. The orientation will be conducted at the convenience of the membership committee but within 90 days after the new member's application, fees and dues are accepted.
4. Each new member will be provided a membership packet which would include but is not limited to Wake-Robin Directory, current year schedule, copy of the bylaws, policy and procedures manual and other documents and information that is necessary to help the new member to be properly informed.

#### Notification Procedures

1. All applications for membership shall be referred to the membership chairperson where upon the decision on membership will be presented to the Club for a vote.
2. Applicants shall be notified by the Corresponding Secretary of the action of the Club regarding membership.

### Membership Fees

**The dues of this Club shall be \$100.00 and shall be prorated by quarters at time of joining.** On or before the time established by the Club membership each year, each member of the Club shall pay their annual dues or fees. Dues and fees shall be in the amount as from time to time determined by the Club membership. Any change in dues will be announced to the members prior to the effective date on the change.

1. The annual dues of this Club shall be due on January 31<sup>st</sup> of each year. **TOTAL DUES MUST BE PAID IN FULL BY THE MARCH meeting.** (Partial incremental payments are acceptable but must be paid in full by the March meeting deadline).
2. Failure to pay by the March meeting shall render a member ineligible to compete in Club Tournaments, vote on Club business or serve as an officer of the Club. Dues not paid in full by the March meeting shall bring loss of membership. In addition, any member not paid in full by the March meeting shall have to apply for reinstatement.

### Meetings of the Club

MEETING RESPONSIBILITY - each member shall be required to co-host a Club meeting. If a member is unable to host her meeting as scheduled, she shall be responsible for making arrangements for a substitute co-host. Any member who fails to host her meeting as scheduled, unless otherwise arranged, shall be responsible for one-fourth of the hosting fee. The check for the fee should be made out to the Wake-Robin Golf Club and sent to the Financial Secretary in the month of the infringement of the rule for reimbursement to the hosts of the meeting.

HOSTESS ROSTER - hostess roster shall run alphabetically with names of new members added with the new year. No new member shall be a hostess during the first year of her membership.

MEETING ATTENDANCE - members shall be required to notify the hostess of her intent to be absent, at least 48 hours in advance of the meeting. During the one (1) year probation period all new members are required to attend 3 of the 5 scheduled meeting held each year.
