

SAN DIEGO BAY

Notes: Please use extreme caution when running your vessel in the southern areas of the bay. There are many known shoals and many unknown shoals in this area and not all are marked. Due to strong naval presence anglers are required to abide by all closures stated on map; in other areas if you are asked to move you must do so. Failure to comply and/or subsequent ticketing can result in disgualification during tournament. We ask that all anglers act in courteous and compliant manner with any authority. Anglers should represent the series in a positive manner towards any person contacting you while fishing. Unlike other venues, many of these areas are not frequented by anglers and therefore many of the locals are not clear on rules, etc. A positive attitude will go a long way! RED ZONES - NO ENTRY OR FISHING

C1: END OF BALLAST POINT NORTHWEST TO WEST

ENTRANCE OF SHELTER ISLAND YACHT BASIN. This area is prohibited by the US Navy and includes the bait barges which are leased and designated for special use only (no fishing). From Ballast Point extending and including all ship docks around end of the 'Sub Dock' down to beach area around the corner

C2: 'AMMO DOCK' AND SURROUNDING AREA.

This area is prohibited by the US Navy. It includes the areas 300 ft. from front/ ends and the area behind iT his is a large dock that occasionally is used by Naval ships.

C3: NORTHEAST CORNER OF NORTH ISLAND.

This area is prohibited by the US Navy and is barricaded by a buoy line. It is permissible to fish outside of the barricades.

C4: US NAVY DOCK AND MIDWAY AIRCRAFT CARRIER. This area is prohibited by the US Navy

C5: NAVAL AMPHIBIOUS BASE (SEAL BASE). This area is prohibited by the US Navy and includes all Naval docks.

C6: NAVAL/NASSCO AND ALL RELATED SHIPYARDS.

This area is prohibited by the US Navy and extends through the privately contracted shipyards to north of the Coronado Bridge. The Vessel Assist docks to the north end are the boundary limits.

NAVAL SECURITY ZONE: USE CAUTION

Technically private boaters are not allowed to fish within 100 yards of North Island along this shoreline, however there is no clear definition as to where the boundary is. If you are contacted by a Naval Security Vessel or any other authority and asked to move you must comply. Please be courteous to all Naval & Police personnel.
