4. OLD BUSINESS

Tree City

There are signs up for tree city that we are using as temporary signs, that Rich built and paid for the

lumber (had receipts to hand in for approval) The plan is to check with Mitch and see what the plan

is on how many signs we will need to have so we can order a group of the signs at a time. Once we

have the amount figured out, we will be checking back in with the pyramid signs in Lafayette to

talk about bulk ordering the Tree Monticello Signs.

Rich also mentioned to the group that we should start to work on getting the next location for a

Tree City picked out. That way we can start the discussion with them and get the plans worked out.

Will need to try to recover the presentation Mitch presented at the Annual Meeting in March. That

will give the District all the information needed to present to the towns and to help with

understanding the process. Mitch has been working on getting the ordnance figured out for the trees

that can be planted, depending on the size of the location and the trees growth rates. Also getting

ready to start the process of adding the tree city information and accessing information to the City

Website.

Rich would like Katie and Mitch to go with him to check out the Tree city Lafayette signs to see

what we can do to make it work for our locations in Monticello. That is because another location

that is in for consideration is at the Roundabouts to make them the main sites for entering into the

city. An idea is to place a larger sign there and a great place for a tree that will grow larger also.

Katie is going to work on getting the contacts for the other towns together and work on getting

them contacted to see if we can present the information about tree city to them.

Landfill Inspection

Discussed what is going to be needed from our district, since the current inspector for the

landfill is going to be leaving. There were questions of to what extent are we able to help other

than the 2 inspections done during the year. Are we able to do water testing or do more in-depth inspections than what we are currently doing? This discussion has been tabled for a later date because there are many questions, we do not know the answers to, and the county is not sure what they are going to be needing from the SWCD.

Katie is going to be reaching out to the Supervisor at Liberty Landfill to set up a date to go out and inspect the landfill for our IDEM spring inspection. Once a date is picked, she will be emailing out to the board and to the commissioners to invite them if they are able to attend the site visit.

River Friendly Recommendations

As of right now there is not anyone in consideration for this award. If there is a recommendation, they will be brought to the board for consideration.

Friends of Conservation Award.

Considering looking outside the typically picked groups of Forestry, looking into conventional farming maybe an idea.

Mitch was brought up as an idea for nomination as he is a larger help to the city on Monticello on working on ways to improve the surrounding areas of the town. There is also discussion of extending that to not just Mitch but to also include the Monticello Parks Dept since they also are a huge role in conservation.

Plat Books

The pictures and information pages for the plat books have been submitted to Mapping Solutions. They are working on getting the plat books completed for us to have them in late June or July. We ordered 75 for the first order and will order more if needed.

Katie is going to make sure we are still within range of what the cost should be for them at the office. Right now, we are at 20.00 per plat book. The price change can depend on if the costs of making the plat books have gone up.

5. **NEW BUSINESS**

Domain Name Paper

Katie received in the mail a letter that was talking about our domain name. She wanted to verify with the board that this isn't something that needs to be paid. As we do have a website and domain established with goDaddy. The board and others looked over the paper and they said

The 319 Grant was awarded to continue with the Big Pine work, the funds will be going towards the work on the new park outside of Oxford.

"What is the vision of White County in 20yrs?" was the question Rich asked the board. The main focus for our county is Ag for conservation. There was discussion of data centers, wind mill, and solar panels. Another question asked was where do we compare to other counties, where should we be on industrial compared to where they are. Do we be more conservative on land zoning or not? The group was agreed upon on being more conservative on land zoning, such as not pro renewable using up fertile land for development.

Conservation Plot outside office

Upon having the meeting, we noticed the lawn care group for the office trimmed the conservation plot where we have our cover plot.

Motion: For the ability to purchase signs to be placed outside the plots to describe what we

are doing and to spend funds to complete the plot such as garden fabric and stakes.
