This agreement is between Puppy Sense ("Trainer") and the Owner ("Client") identified above pertaining to behavior modification of the pet ("Pet") identified above.

\_\_\_\_ (initials) Trainer agrees to provide group/private lessons for Client and Pet, the goal being to teach Client how to train and work with Pet. These lessons will take place at a location predetermined by Trainer. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Pet's performance or behavior as a result of providing professional animal behavior consultation. Client understands that he/she and members of the household must follow Trainer's instructions without modification, work with Pet daily as recommended, and constantly reinforce training being given to Pet.

\_\_\_\_ (initials) All fees shall be paid prior to commencement of class/training sessions. There is a fee of \$25 for returned checks.

\_\_\_\_ (initials) For group classes, missed classes cannot be made up. Reservations are Non-Refundable. If fourteen (14) days prior to commencement of the class Client determines they are unable to attend, the reservation may be credited to another course commencing within six (6) months. Less than fourteen (14) days prior to course no refund will be given.

\_\_\_\_ (initials) Trainer, at his/her sole discretion, may remove Pet from class or conclude one-on-one session if a hazard or threat of any nature to any other animal or person is present. No refund will be given under such circumstances.

\_\_\_\_ (initials) Trainer, at his/her sole discretion, may cancel this contract for any reason. Health and Safety:

\_\_\_\_ (initials): Client agrees to clean up and properly dispose of any of Pet's waste.

\_\_\_\_ (initials): Client certifies that Pet is in good health and has not been ill with any communicable conditions within the past 30 days. Pet has not been exposed to Rabies, Distemper, Parvo, Ring Worm, Parasites or Kennel Cough within a 30-day period prior to enrollment. Client further certifies that Pet is current on the following vaccinations for their Pet's age: Rabies, Distemper, Parvo and Bordetella. Client agrees to provide proof of vaccinations upon request and agree to keep Pet's vaccinations up-to-date during program/class.

\_\_\_\_ (initials) Client agrees to notify Trainer at least twenty-four (24) hours in advance of class or session if Pet is showing signs of illness. Trainer at their discretion will decide whether Pet may attend class or the session.

\_\_\_\_ (initials) Family participation is encouraged. For the safety and well-being of all participants, Client agrees to maintain control and supervise their children under the age of eighteen (18.) Children must remain within Client's training area throughout the class for the safety of the child and the other participants. Client agrees that they will instruct child to only interact with their own pet and never approach or touch another pet.

\_\_\_\_ (initials) Client hereby irrevocably grants to Puppy Sense, any and all rights to use and incorporate, in whole or in part, their image and Pet's, whether it be represented in a still photograph or video, their name and likeness and/or Pet's name and likeness, for reproduction in any and all media for purpose of advertising, trade, display, exhibition, editorial, use or other use as determined by Puppy Sense in its sole discretion. Client understands and represents that they have the right under applicable law and customs to grant full permission to use their name and likeness and/or Pet's name and likeness hereunder. Client hereby waives any and all rights to inspect and approve the finished product or copy that may be used in connection with the image of themselves and/or Pet that may be used by Puppy Sense.

**Liability:**

\_\_\_\_ (initials) Client acknowledges and agrees that they are solely responsible for Pet and Pet's action. Client acknowledges and agrees that any training that is received or contracted for does not guarantee whatsoever that Pet will behave as expected and that application of the behavioral advice and training suggestions is voluntary. Client hereby indemnifies and holds harmless Puppy Sense, all officers, instructors, trainers, employees, independent contractors and insurers of any liability for loss for of Pet or Pet's action including but not limited to, intentional or unintentional actions that cause harm or loss to a human being, animal or property during the training period or at any time in the future

\_\_\_\_ (initials) Client hereby holds Puppy Sense harmless of any liability for any loss or damage to their person, Pet or property including, but not limited to, loss or damage from disease, other persons, other pets, training aids, equipment, Pet running away, fire or other unavoidable causes. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement no promises, representation or oral understandings have been made with regard to Pet or anything else. This agreement may be amended only by a written instrument signed by both Client and Trainer.
