## **TOMMIE BARFIELD**



Tommie Barfield was a strident voice from the wilderness, pleading for progress, in an era when women were seen but not heard. She is important to us because of her advocacy of the Tamiami Trail and the formation of Collier County but she also played a vital role as a community leader on Marco Island.

According to a quote from the *Tampa Tribune* of May 10, 1923, referring to the legislation which created Collier County, "Mrs. Barfield of Caxambas is being given much credit for the passage of the bill by the House last Thursday night ... As a lobbyist, Mrs. Barfield has few equals ...".

"Tommie" Camilla Stephens was born in Georgia in 1888 and moved to Marco Island with her family in 1901. She married James Barfield, a pineapple farmer, and helped to run the general store and hotel they owned. She was instrumental in having a road built across the island between the villages of Caxambas and Marco and in getting a ferry to the mainland. But, as well as her public petitioning, she was known locally for her kindness to her neighbors during times of hardship.

You can read more about this remarkable woman in "A Girl Called Tommie; Queen of Marco" by Betsy Perdichizzi & Kathryn Kirk. Betsy herself is extremely active on Marco Island, having spearheaded the drive to build an historical museum which would be suitable for the repatriation of the famous Marco Cat from the Smithsonian.

Betsy says her interest in history goes back to her youth in Texas and Oklahoma when she traced her ancestors back to the early 1700s in Virginia and gained an appreciation of how hard pioneer life must have been. She will have copies of her books available for sale after the presentation on March 20.

## **McLeod Park Anniversary**

Among the many anniversaries we are celebrating this year is the 40<sup>th</sup> for McLeod Park which now encompasses the playground, pavilion, and tennis courts next to City Hall. In 1968 the Lions Club offered to help the City with a park (Council Minutes Book, 10/1/68) which was finally named a few months later in honor of long-serving Mayor D. W. McLeod.

Daniel William McLeod (1888-1960) came with his wife Lucy McKeown McLeod (1892-1963) by boat from the Florida Panhandle in 1923. According to their grandson, James D. Brown, McLeod "*was somewhat of a land expert at the time, which Mr. Collier needed for the development of Collier County. Lucy became an expert by on-the-job training. Needless to say, they were both very intelligent. My Grandmother used to tutor me in algebra when I was in Jr. High School.*"

Besides operating the only property abstracting and title service in the new county, D. W. McLeod was also the tax assessor. He became the first Mayor of the town of Everglades in 1923 and was elected unanimously in 1953 as the City's Mayor during the Council's first meeting on July 7. He continued in office until December 1, 1959, when his last act was to swear in his successor, Dr. Kenneth Synder. Unfortunately, McLeod died less than a year after that.

Both the McLeod's are remembered fondly by local residents for their kindness and leadership. They lived in the house on Broadway at the river's edge, opposite the Rod & Gun, and Lucy buried her pet parakeet Cheri in the median.

ESHP has offered, after encouragement from the McLeod grandchildren and the present Mayor, to build a monument with brass plaque commemorating the McLeods that will be placed in the park. The plan is to hold the unveiling during the Tamiami80 celebrations on April 26/27.
