MAYOR SAYS "KEEP RAISING MONEY!"

City Hall was condemned after Hurricane Wilma struck Everglades City on October 24th but Mayor Sammy Hamilton has said repeatedly, publicly and privately, that he is determined to save the building.

Some **temporary measures** have already been taken; the roof has been patched up and the inside has been cleared out and treated for mildew.

Although he is talking with FEMA, the Mayor warned that we should not stop raising money to restore City Hall "*We need all the help we can get*". Large donors may even have rooms named after them when the building is finished. But, any contributions are welcome ... large or small.

Special Category Grant

Architect Dan Summers, Karen Cabral and Marya Repko attended the hearings for the Special Category Grants from the Bureau of Historic Resources at the Department of State on November 8-9 in Tallahassee. We were **welcomed sympathetically** because of all the fantastic media coverage after Wilma.

Unfortunately, the City Hall project ranked 45 and the funding budgeted by the legislature stops at project 43. However, there is a chance that more money will be voted in. Please lobby your state representatives for increased funding.

FUND RAISING



The last newsletter was mailed to over 200 selected addressees who were known to have an interest in history. We gained 6 new memberships from this **mail-shot** and, hopefully, made more Collier County residents aware of the plight of the original Courthouse.

We sent unsolicited letters to almost 100 private **charitable foundations** in Naples and are hoping for a positive response before the year-end. Volunteers Mari Varello and Robin Barnes are following up with phone calls. We also investigated large philanthropic donors on the Internet and filled in several applications.

Carol Moseman and Marya Repko attended a seminar held by the **Community Foundation in Naples** to learn about grants that are available from them for training, consultants, technology, and community projects. Possible uses for ESHP would be hiring a fund-raising consultant for a specific event (eg, the bike rally) and contracting an Internet website provider.

MEMBERSHIP

We have 63 paid members: 2 benefactors, 7 patrons, 23 individuals, 19 families, and 12 businesses. Of these, 38 receive their newsletters by email, saving about \$14 per issue and the effort of stuffing envelopes. Renewal notices will be sent out in the New Year.
