WHEREAS, GOVERNMENT CODE 29130, provides that canceling reserves may be available for specific appropriation by a four-fifths vote of the Board at a noticed public hearing held as part of any regular or special meeting of which all members have had reasonable notice; and,

WHEREAS, the Kelseyville Fire Protection District has reserves designated for "Medical Services and Equipment" in the amount of \$1,788,553; and

WHEREAS, the Kelseyville Fire Protection District recognizes the need to appropriate funds from Medical Services & Equipment (IGT) reserve accounts to participate in the State Intergovernmental Transfer Program.
