RESOLUTION NO. 2026-08

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE KELSEYVILLE FIRE PROTECTION DISTRICT INCREASING RESERVES AS A RESULT OF PARTICIPATION IN THE STATE INTERGOVERNMENTAL TRANSFER PROGRAM

WHEREAS, Government Code 29130 provides that excess revenue may be available for specific appropriation by a four-fifths vote of the Board at a duly noticed hearing as part of any regular or special meeting of which all members had reasonable notice; and

WHEREAS, the Kelseyville Fire Protection District (KFPD) has received unanticipated revenue in the amount of \$837,435 from Partnership Health Plan California for an Intergovernmental Transfer ("IGT") Program; and

WHEREAS, the sum of \$801,975 has been determined to be in excess of KFPD's 2024 unreimbursed costs from medical services provided to Partnership Health members and must be expended on health care services, including, but not limited to, salaries, supplies, and equipment; and

WHEREAS, any amount used from the Medical Services & Equipment reserve to participate in the IGT Program does not satisfy the contractual obligation to use the funds on health care services in the Plan-Provider Agreement (section F); and

WHEREAS, the Board of Directors passed Resolution 2026-05, canceling reserves to participate in the IGT Program with the intent to replenish reserves with any excess revenue.

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors of the Kelseyville Fire Protection District directs the County Auditor-Controller to replenish reserves and increase the budget according to the following:
