Do you support the Affordable Care Act? Please explain. *

We need to lower prescription drug costs and make sure that healthcare is both affordable and available. Should government take action to reduce fossil fuel consumption to address climate change? Please explain. *

What additional restrictions on gun ownership do you support, if any? Please explain. *
