Privacy Policy

This Privacy Policy ("Policy") applies to showroomtravel.com, and Showroom Travel LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include showroomtravel.com, Postgame Cruise and postgamecruise.com. The Company's website is a Travel service site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties

Automatically Collected Information

The Company may automatically collect information about your computer hardware and software. Use of Cookies

The Company's website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - -Comply with the California Electronic Communications Privacy Act;
- -Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
- -Enable solely internal uses that are reasonably aligned with your expectations based on your
- -Comply with an existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible wi
