### **OFFICIAL RULES & REGULATIONS AGREEMENT**

•	, as a candidate in the <b>2018 Love of Country Global Ambassadors</b> a <b>m</b> ("Program"), an international leadership and cultural ambassadors competition organized by Asian Journal ations, Inc., (AJPI) do hereby agree and bind myself to strictly and unconditionally comply with the following:
I. REPF	RESENTATIONS
l hereb	y certify that:
1.	All information in my official application forms are true and correct.
2.	I was born on in and I am in good health.
3.	I have never engaged nor participated in any unlawful, lewd, indecent, or immoral action.
4.	I am not a party to any existing contract which would conflict with services to be performed by me in

- connection with the Program either as an official delegate or as one of the lead Ambassadors. Such conflict exists if, in the sole determination of the Love of Country Global Ambassadors Program:
  - A) The obligations and duties expected of me from such existing contract are in conflict with the duties and obligations expected of me as a delegate or as the lead Ambassador; or
  - B) The terms and/or conditions of such existing contract are in conflict with the terms and conditions of this contract; or
  - C) Any of the parties to such existing contract is an individual or an organization, group, association, company, or corporation which is a Competitor, direct or indirect, of any of the sponsors of the 2018 Love of Country Global Ambassadors Program.
- 5. I authorize AJPI to act as my exclusive agent and handle all my personal appearances on radio, TV, and print media in connection with the Program. I recognize AJPI's right to use the presentation of the Program or any portion thereof, in any manner it deems fit, without consent from or payment to me. I further authorize AJPI to use my name, photograph, autograph, likeness, and voice recording, for any and all publicity purposes. In this regards, I hereby waive any copyright I may have to the said materials.
- 6. I accept that the sole obligation of AJPI is to accept me as a delegate, provided I satisfy all eligibility requirements and comply with provisions of this agreement.

#### II. TERM OF CONTRACT

The term of this contract commences upon signing and terminates upon:

- 1. Disqualification or withdrawal as a delegate;
- 2. Elimination in the Program;
- 3. (6) Six months after relinguishment of title or expiration of the Program.

### III. DUTIES AS A DELEGATE

- 1. I shall strictly obey all rules and punctually keep all appointments. All my activities during the Program shall be fully controlled by AJPI and I shall cooperate to the fullest with AJPI and its representatives.
- 2. I shall attend all official, environmental, social, and events/functions of AJPI as well as the sponsors, and I shall provide myself with an adequate wardrobe to meet all functions. I shall appear in cultural gown should the occasion demand it.
- 3. As the official delegate for the Love of Country Global Ambassadors Program, I shall stay with the program and willingly and wholeheartedly participate in all activities and functions until the termination of the year of the Program, unless I am eliminated at an earlier date. I shall strictly abide by all of the Program's rules and regulations and shall accept any decision of AJPI and/or the Program's Committee as absolutely final and not subject to any appeal for all legal intents and purposes.
- 4. For the duration of my stay as an official delegate, I shall not, without the written consent of AJPI, make any personal appearances for the promotion of any product and/or merchandise; permit the use of my photograph or give any writer or verbal endorsement; or enter into any contract agreement with any organization, company, or individual.
- 5. Before, during and after the Program, I shall not by myself or with the assistance or connivance of any person or entity, engage in any action, scheme, plan, or design by means of any medium, or behave in any disorderly, unruly or demeaning way, which will, in any manner, cast aspersion or put the Program organizers and/or officers in a bad light.
- 6. In the event I am disqualified from the Program, I shall hold AJPI harmless and free from any and all obligations whatsoever.
- 7. If I decide not to continue as a delegate, I will have to pay for all expenses incurred by being an official candidate of the Love of Country Global Ambassadors Program (clothes, board and lodging, transportation, etc.). I shall also return prizes and gifts I received during the Program, if any, upon my withdrawal.

## V. DUTIES AND RESPONSIBILITIES AS FINALISTS AND PRE-FINALISTS

1. As a finalist and pre-finalist, I acknowledge that I will be bound to work for the Love of Country Global Ambassadors Program and by certain responsibilities and duties to AJPI for an additional (6) six months after my reign and therefore obligate myself to the following:

A. To represent the Philippines in international programs and initiatives that the Love of Country Global Ambassdors Program are meant for. As such, I shall travel to the place where the respective international programs are to be held and obey all the rules and regulations of the said programs.

B. To abstain from or engage in any activity or behavior which, in the sole determination of AJPI, will be in conflict with the duties and/or image as a leader.

- C. To assist the sponsors and other individuals and/or companies in advertising and promoting their products as AJPI may designate, including but not limited to:
  - 1. Participation in promotional activities, fashion shows, and other personal appearances, free of charge.
  - 2. Personal endorsement of products and use of my name, likeness or photograph, voice recording in the advertisement and/or sale of products for commercial purposes by any one of the official sponsors to the Love of Country Global Ambassadors Program, free of charge.
- D. Not to commit to any individual, organization, company, or other third person to appear or pose; make use of my name, autograph or signature; to take, publish, reproduce or cause to be reproduced any of my photographs at any time during the course of my reign for commercial or other purposes not associated with the Program, including publicity, advertising, sales, television shows or taping for movies and commercial radio as as personal appearances in fashion shows or other similar activities without the written consent of AJPI.
- E. I shall not make any public appearances, endorse any product, sign any movie or commercial contracts, or allow my name, likeness and voice to be used in any connection with the advertisement or sale of any product or service without the written permission of AJPI.
- F. I shall not accept any engagements outside of the schedule made by AJPI. I shall fulfill the personal appearances itinerary prepared for me by AJPI. Should AJPI officials decide to have either a Philippine or Asian tour, I hereby bind myself to go on this proposed tour with no monetary consideration as this is my bonus prize for winning the title. It is, however, understood that AJPI shall provide me with airfare/airline tickets, hotel accommodations and meals/meal allowances.
- G. I shall attend all activities, when AJPI so requires, whether charitable or social, including but not limited to the social events of the organizers and sponsors of the Love of Country Global Ambassadors during my reign.
- H. I shall submit for approval of AJPI all my wardrobe and wardrobe designs which I shall bring to the international competitions with the understand that AJPI shall have the option to change any item of my wardrobe or to design another one as the case may be.
  - I. I shall assist in the promotion of the following years of the Love of Country Global Ambassadors Program, as well as make personal appearances in regional contests or similar activities.
- 2. For the duration of my reign, I hereby appoint AJPI as my sole and exclusive Talent Agent and authorize same to enter into contracts or agreements involving my appearances or performances. As such, AJPI shall be entitled to thirty percent (30%) of all my talent fees, whether or not my talent fees were earned as a result of AJPI's bookings.

# VI. GROUNDS FOR DISQUALIFICATION AS A CANDIDATE OR DETHRONEMENT AS A FINALIST OR PRE-FINALIST

I understand that the following are the grounds and causes for either my disqualification or resignation as a delegate or dethronement or resignation in case I am declared the winner:

- 1. Misrepresentations or untrue statements in the Official Application Form.
- 2. Failure to immediately perform any of the duties, responsibilities, and/or obligations, either as a delegate or winner.
- 3. Entering a/other Programs during reign as winner or runner-up.

- 4. Refusal to accept the designation to international programs or withdrawal from programs when adjudged winner or runner-up.
- 5. Violation of any of the provisions and/or representations contained in this contract.

I further understand that my disqualification or resignation as a delegate or dethronement or resignations as an Ambassador, based on the foregoing grounds and causes will result in the immediate forfeiture of all the privileges and prizes due me, as well as revocation of all privileges and/or return of all prizes granted to me and expenses occurred as a result of my participation in the Program, without prejudice to any claim for damages which AJPI may be entitled to under the law.

VII. I have read the contests of this agreement, and have signed and initialed each and every page voluntarily, with full knowledge of my obligations and responsibilities and the consequences of a breach of any of this contract's

provisions.	
VIII. AJPI shall have the right to terminate this Agreement at any time before the expiration hereof, by a written to me, in case, in the determination by the Program Organizer, I have violated any of the terms and conditions of Agreement.
