### **PRIVACY NOTICE**

Bolton le Moors Car Club Limited respects your privacy and we will only use your information in the way we describe in this notice. When using your information we aim to be fair and transparent and to follow our obligations under UK data protection laws. Your information is used for administering club membership, activities and competitions.

Bolton le Moors Car Club Limited is the data controller for the purpose of General Data Protection Regulation and the Data Protection Act 2018. ### **Collecting your information**

We collect your information when you fill in membership application or renewal forms, and competition event entry forms. You can give us your information using paper forms or online forms. The information you give us may include your contact details (name, address, telephone number, email address), personal information and identifiers (date of birth, membership number, competition licence number), and other information (vehicle details). When you give us information about another person, such as a child, parent, guardian, or emergency contact, you should let that person know that you have given us the information.

If you are under 18 years old, we will also ask for information from your parent or guardian.

### **Using your information**

We use your information when you first apply to become a member of Bolton le Moors Car Club Limited and then to administer and renew your club membership and provide you with member benefits. We also use your information when you enter club events. For competitions, we will publish some of your information in the programme and the results, which will be in the public domain. Your information is used in these ways to fulfil our contract with you.

We may ask you for emergency contact and next of kin details which we will only use in an emergency for a legitimate reason. You should let the contact and next of kin know that you have given this information to us.

We might use your information to send you marketing messages by email about forthcoming events, but not if you have indicated that you do not wish us to do this. You can change your mind at any time just by letting us know. We will not sell your information to another organisation.

To support your lifetime relationship with motorsport and Bolton le Moors Car Club Limited, we may keep your information indefinitely, unless you ask us to delete it.

### **Sharing your information**

We may share your information with Motorsport UK as required by its General Regulations for governing motor sport, with other Motorsport UK Registered Clubs, with medical personnel, or
