WAIVER/RELEASE - In consideration of being allowed to participate in any way in Mohawk Archery Club events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from archery and other known and unknown events and activities and/or the use of related buildings structures, equipment, automobiles, firearms, weapons, ATVs, boats, tree stands, roads, bodies of water, land and all other real and personal property whether owned by Mohawk Archery Club or others is significant including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and

2. I acknowledge and agree that the use of archery equipment, firearms, and other weapons by others or myself on the Mohawk Archery Club premises or otherwise are inherently dangerous and high-risk activities whether such archery equipment, firearm or weapons are discharged by others or myself; and

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and

4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and

I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS MOHAWK ARCHERY CLUB, MOHAWK ARCHER, its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and Lessees of real property and personal property used to conduct the events and activities ("RELEASEES") with the respect to any and all injury, disability, death or loss or damage to personal property, whether arising from negligence of the RELEASEES or otherwise to the fullest extent permitted by law.

Mohawk Archery Rules, Regulations, and Conduct Requirements

CONDUCT

- **Absolutely no shooting under the influence of drugs or alcohol.**
- **No discharge of firearms is allowed at any Mohawk Archery Club event or range. No knife or axe throwing.**
- **Smoking is not permitted in the indoor range.**
- **No horseplay allowed at ranges.**
- **Archers age 16 and under shall be accompanied by an adult.**
- **Be considerate while others are shooting. Keep conversations at a low volume or move them to the conference table area in the range.**

HOUSEKEEPING

- **Clean up your trash; do not leave it for others to pick up.**
- **Rolling targets, chairs, floor quivers, bow racks, etc. will be moved back to their assigned location.**
- **If you are the last shooter at the range you will turn off all lights and the radio and lock the downstairs door as you leave.**
- **Food and drinks are not permitted beyond the 20 yard shooters line.**
- **Remove paper targets or other types of targets, and target pins from the target butts or rolling butts after you complete shooting. Paper targets will either be recycled or discarded.**
- **Sweep up and discard scraps of target paper, target debris or 3D foam pieces from floor after shooting.**

TARGETS AND CLUB PROPERTY

- **Only archery equipment shooting round field points shall be used in the indoor range.**
- **No Broadhead or practice broadheads may be used in the indoor range. Failure to comply may result in the reimbursement for the price of the targets that have been shot.**
- **3D targets- Only shoot at the vital areas of the 3D Targets. Intentional shooting at non-vital areas of a target may result in the replacement of 3D targets by the club member.**
- **No defacing (writing or marking) or applying stick on style target dots directly to target butts or 3D targets.**
- **Rental property, bows arrows, etc., must remain in the indoor range and returned to the closet and locked up after use.**
- **Intentional/negligent damage or vandalism to club property may result in your reimbursing the club for that damage.**
