## MEMBERSHIP AGREEMENT AND WAIVER OF CLAIMS

### MEMBERSHIP

**Nature of Membership.** Membership is a non-transferable right which confers on Member the sole right to use and enjoy the classes offered by TKD Elite USA in accordance with the rules and regulations as adopted and/or amended by TKD Elite USA.

**Nondiscrimination.** TKD Elite USA accepts all membership applications from any individual, family or business organization of good character and responsible payment history without regard to race, creed, color, sex or national origin.

**Dues and Fees.** Monthly membership varies by membership classification. Members agree to pay dues based on their membership choosing. The obligation to pay dues is not dependent on the availability of the facility. Dues will be reduced or suspended during the time when the facility is not available.

(a) Leave of Absence. If at any time the member suffers a prolonged medical condition that prevents the member from attending classes the member may cancel the membership, without any penalty, provided the member provides Tae Kwon Do Elite USA with a written doctor's certification verifying the member's inability to continue training classes. The member shall be responsible for all dues and fees incurred prior to receipt of written doctor's order.

**Charges.** Member, co-applicant and dependents, may use an approved credit card on file to purchase any non-recurring goods and services.

(a) Online Servicing System. TKD Elite USA has an Online Servicing System where a member is able to donate and/or purchase merchandise, equipment, apparel, etc. Member understands and agrees that by using the online system, members will be bound by any such electronic commitment pursuant to the terms and conditions of this membership agreement and as set forth in the Uniform Electronic Transaction Act.

### RULES, REGULATIONS, AND POLICIES (collectively "Policies")

**Publication and Access.** TKD Elite USA has adopted Policies for the use of classes at TKD Elite USA which all members and guests are expected to honor as a part of this membership agreement. Members are to abide by the "Oath of Membership"

### TERMINATION OF MEMBERSHIP

**Voluntary Resignation.** Members may resign by giving a 30-day written notice to terminate membership with Tae Kwon Do Elite USA. Voluntary resignation shall not be deemed effective until after the expiration of the 30-day notice period and after all required payments (dues and any other occurring charges) have been made to Tae Kwon Do Elite USA. Subsequent to voluntary resignation, the member shall not be subject to any further dues or other charges. Non-use of classes is not considered notice of cancellation. **Involuntary Termination.** TKD Elite USA reserves the right at any time to terminate the membership of any member for failure to comply with any Policy adopted by TKD Elite USA or for any conduct TKD Elite USA determines to be contrary to the best interest of TKD Elite USA. The membership may be terminated by notification in writing to the email address on file. A terminated member will remain liable for all dues and other indebtedness incurred prior to the effective cancellation date. The membership of any member who is 30 days in arrears with respect to the payment of his/her account to TKD Elite USA may, at TKD Elite USA discretion, be terminated.

### APPLICANTS MEMEBRSHIP IS SUBJECT TO THE APPROVAL OF TKD ELITE USA.
