#### I. Welcome:

a. Bonnie opened with the Serenity Prayer

### II. District Rep.-Bonnie R:

## a. Minutes Secretary Lil:

- 1. Correction to minutes:
  - a. Sandra provided the correct spelling being ALEX, and correction to the date on the minutes
  - b. Charlene stated to add an 'e' to La Verne and the Patricia was missing an 'l',
- 2. Motion made to approve the minutes with corrections by Charlene. Motion seconded by Toni G.
- 3. Minutes were approved,

#### IV. Contribution Treasurer-Terri T

- a. Terri reported our contribution for December came a total of \$250.00.
- b. A large 7<sup>th</sup> Tradition of \$46.00, for meeting in-person
- c. Total came to \$296.00.
- d. Terri's secondly reported annual totals for group contributions.
  - 1. Terri suggested to the GR's to make a copy and report the amount to their meeting.
  - 2. Charlene noted that on group number 308-19024, Tuesday meeting. Reflects 'seminity' it should read 'serenity'.
  - 3. Total contributions for the year were \$2,091.93, from group meetings.

#### V. Disbursement Treasurer - Laura V

- a. Laura reported that the December operation funds began with \$2,844.75
- b. Expenses for the month of December 11 were
  - 1. \$100.00 for rent at the La Verne Church.
  - 2. Additionally, the monthly bank fee of \$2.00
  - **3.** Total deduction of \$102.00 with the contributions reported by Terri we have an ending balance of \$3,038.75.
  - **4.** With our prudent reserve we have a balance of \$5,038.75.
  - **5.** Bonnie asked for clarification and Laura provided detailed information, regarding that our ending balance for December should be under \$3,000.00
  - c. Bonnie asked Yvonne if we have \$38.75 to spend. Yvonne clarified the question by stating what the maximum amount is to be at the end of the year. Yvonne responded to maintain our non-profit association status in order to not have to file formal tax return, the limit is \$5,000.00

- 1. Laura stated we are over \$38.75 and reported that Irene mentioned she might have some expenses to submit for December or January.
  - a. Bonnie asked if anyone has expenses from a workshop, literature, or Alathon to submit expenses.
  - b. Yvonne believed that there might be a website bill or something and date the check December 31st and amend the report and submit next month.
  - c. Laura submitted a budget, Bonnie found it hard to follow. Bonnie stated she will put together a budget committee for January 29<sup>th</sup> on a Wednesday at 5:45 pm. Attendees being Denise, Lil, Terri, Laura, Yvonne, and herself. Bonnie invited anyone who is interested in attending, please feel free to attend.
- **VI.** Bonnie reported on the vacant positions i.e. Alternate DR, and Group Coordinator. Bonnie if anyone was interested in being group coordinator.
  - a. Terri nominated Yvonne as group coordinator and second by Charlene. Yvonne won the nomination.
  - b. Bonnie stated that we do not have an Alternate GR she is breaking from tradition and asking for someone in the group to a Workshop Chairperson for this year or until we get another Alternate GR.
  - c. In-Person meetings:
    - 1. Bonnie suggested that the district group would decide what to have at the in-person meetings, e.g. finger food, speaker, or no speaker
    - 2. Yolanda has the contract for the in-person meetings
  - d. .Bonnie stated she would remain silent and leave the floor open
    - 1. Katherine will go first with a question for Public Outreach; Katherine asked for suggests, e.g. what is important for the community
      - i. Lil suggested starting with Alateen. Tina reported the goal was to have contact with all the unified school districts in our area and to talk with the school counselor and to visit on site
      - ii. Additionally, provide Alateen literature to the campus and to start up an Alateen meeting letting the parents know we exist.
      - iii. Create panels that would go to group homes, hospitals, and rehab facilities
      - iv. We do not do things alone, for example World Service has a public outreach person you could reach out to get additional information
      - v. We are not promotion but attraction
      - vi. AIS for LA County
      - vii. Katherine asked "do you have to have another person with her." She will contact the World Service office to get the suggestioned literature that should be handed out.
      - viii. Charlene suggested seeking community fairs and seeing if they allow you to have a table to display your literature, Charlene also suggested asking an Al-Anon friend to join you at these fairs. Again, we do not promote but if someone comes up to the table you can hand them information. Additionally, she suggested providing literature at libraries, sometimes they have a display case, and where they may allow you to place Al Anon literature. Shelters for battered women is another place to provide literature. Katheine will to Laura she stated she had some suggestions for outreach.
      - ix. Yvonne offered a suggestion she has a list of literature that is all inclusive and they are inexpensive. She will send the list to you, and you can see if that is something you might want to use. She also stated that they purchased some Al-Anon books and saved them to local libraries. Yvonne also suggested that it is fun to form a committee with some of your Al-Anon sisters or ask at a meeting if someone would like to participate. Sandra reported that Tuesday night Monrovia meeting is still going to continue with their Friday night outreach however with the recent fires to see if the farmers market will still be held.
      - x. Denise informed Katherine that if she needs any literature, she can order it for her. Denise will go through her inventories of literature. Additionally, there are little cards that were

gave given to Frances for the Alathon that come in English and Spanish it asked does someone's drinking bother you and it has alanon.org printed on the card

    - iii. Sandra is concerned for the location of this year's Alathon
    - iv. Sandra would like to find a site in Monrovia. This would bring more people from the outer edge to participate.
    - v. Sandra inquired if anyone knew of a site she could contact. Lil suggested the Mary Vale site on Huntington drive in Duarte.
    - vi. Tina suggested looking at the churches where we hold meetings, i.e. AA meetings or Al Anon meetings.
    - vii. Sandra will reach out to the district group
    - viii. Bonnie provided Sandra with Patricia's and Frances's phone number.
    - ix. Bonnie suggests to Sandra to ask Patricia about speakers
