Nalls site plan approved by the Town and all local, state, federal agencies and provided to applicant for building permit submission to the County of Caroline.

The site plan process of Royal Farms continues. VDOT found plan approvable. Royal Farms submitted boundary line adjustment plat and re-submitted site plan for second review. Town waiting for the Virginia Department of Environmental Quality to finish review of stormwater.

Giles house remains under construction.

Grass cut at property at intersection of Route 17 and Route 301. Request to contact owner as some areas were missed.

Ongoing trash complaints in trailer park reported. Staff will follow-up.

## Report of the Town Manager

Question whether Town is issuing business licenses to businesses who are not submitting tax forms. The Town Manager stated she will review the tax code for clarification. Honor system has been used historically but submitting tax forms is the only way to provide assurance that the correct BPOL tax is paid.

Municode contract underway. Committee to be established to review Town code.

Landscaping at Town pier to be decided.

More decorative historic reproduction streetlights along King Street requested by citizen.

Litter grant for FY23 to be awarded soon.
