# 8-13 Report of the Town Clerk/Town Zoning Administrator/Town Manager

The final site plan for Royal Farms has been approved and signed. The Town Manager is distributing approved plans to all local and state agencies with oversight of the project including Virginia Department of Health, Caroline County Planning and Building, Virginia Department of Transportation, and Virginia Department of Environmental Quality.

Per request by the Town Council the Town Manager provided information on status of water system identified in water reports previously prepared by engineering consultants.

The Town Council requested priority of installation and training of the new AED in Town Hall. JP Wilkerson will obtain training for Council and staff.

#### 8-14 Board/Commissions/Agency Representative

The mayor is actively seeking members to fill positions on the Board of Zoning Appeals. The Town Council will eventually move request to the Circuit Court for approval and appointment.

### 8-15 ACTION ITEMS

# 8-15.1 Cigarette Tax Ordinance

A draft ordinance was reviewed. The Mayor and Town Manager will seek further guidance on procedure for enactment.

### **8-15.2 Mobile Homes**

On the motion of Donna Wilkerson, seconded by Angela Golden, which carried a vote of 5-0, the Town Council voted to hold a joint meeting with the Planning Commission on August 22 at 6:30 pm for discussion on amending the zoning ordinance to remove mobile homes as a use in some residential zoning districts. This measure will protect public health, safety, and the well-being of the community, including the historic significance of the Town. This change in ordinance is for purposes of preventing placement of additional mobile homes in Town and will not impact any existing structures. The Town Council requested sending a draft ordinance to the Town Attorney for review.

#### 8-15.3 Rappahannock River Withdrawal Permit

The Joint Rappahannock River Withdrawal Project requires revision of the letter submitted to the Virginia Department of Environmental Quality by Port Royal to allow the Town to participate in the project. The Town Manager provided a draft which will be further reviewed and revised by the Mayor for consideration by Town Council at a meeting on August 22 at 6:30 pm. The Town Council further discussed other issues about the project including proposed location of the future water line.

The Town Council meeting took a five-minute break.

#### 8-15.4 Retainer versus Hourly Rate of Town Attorney

Per the request of the Council, the Town Manager spoke with the Town Attorney and provided an hourly rate for services if the Town chooses to pay for legal services hourly rather than a monthly retainer.

### 8-15.5 CD - Roll Over or Cash Out

On the motion of Angela Golden, seconded by JP Wilkerson, which carried a vote of 5-0, the Town Council voted to authorize Vice-Mayor Donna Wilkerson and Mayor Alex Long to roll over the existing CD (original value \$50,000) into a new CD with yield of 4.89% for 7-months and move an additional \$100,000 from the general fund into a 7-month CD at 4.89% yield.

Council members questioned the value of having a decal fee due to the cost of staff time versus total collections. Council requested this item be placed on the September agenda for further discussion and possible action.
