If the part happens to fail within 30 days of purchase, **Town & country Auto Parts**. reserves the right to provide another part and will continue to do so until the warranty is over and you must return the purchased part. **Town & country Auto Parts**. does not guarantee the parts purchased from us will fix the problem with your vehicle and under no circumstances do we offer any type of refund if it does not.
- 2. All engines are warranted against cracked cylinder blocks or heads damage, bad cam or crankshafts, excessive smoking, and to be in good running order unless otherwise stated. Gaskets and seals are not covered. All engines purchased from Town & country Auto Parts. have a heat tab installed. If the tab has melted, been removed, or tampered with, warranty is void. - 3. All used engines purchased from **Town & country Auto Parts**. must have new oil and filter installed upon installation, and be changed every 3,000 miles thereafter.
- 4. All engines are sold as long blocks only, all components including relays and sensors must be changed as needed.
- 5. This warranty does not cover attached items ( water pump, fuel injection, distributor, computers, sensors, relays, etc)
  Although these items may be left on the engine you purchase, they are there for convenience and there is no assurance of proper fit.
- 6. All used transmissions purchased from **Town & country Auto Parts**. must have new seals, filters, and oil installed at the time of installation. You must use the fluid the transmission calls for. (eg. Honda trans Honda fluid, VW trans VW fluid etc.) Transmission coolers and lines must be flushed before installation or the **warranty is void**.
- 7. All vehicles which have a **Town & country Auto Parts**. engine or transmission installed must have the proper capacity cooling systems and must be flushed or replaced upon installation, or the **warranty is void**.
- 8. When a warranty claim is requested for an engine or transmission, these parts shall remain installed in the vehicle and be brought to **Town & country Auto Parts**. to verify the problem, and validate the warranty claim, unless other arrangements have been made and authorized by a manager prior to any repairs.
