11 April 18th, J.G. told D.M., which is how she came
12 into the fold.
13 May 1st, I told D.M. because she was
14 already in the mix.
15 May 21st --
16 Q. And if you could just for the record, so people
17 don't have to refer back, could you just give a
18 short descriptive phrase about what each date
19 involved?
20 A. So April 18th was the initial tackle me on my couch.
21 May 1st was the, what I've referred to as J.G.'s
22 mental breakdown.
23 Q. And what was the action?

1 A. Where he tried to kiss me. May 21 is when he pulled
2 down his pants and asked for a hand job for his
3 birthday.
4 Q. Who did you tell about that?
5 A. That, I'm sorry, I told Kayleigh Rose that. So that
6 happened on a Wednesday. Kayleigh and I were at a
7 bar for Fleet Week that Saturday, and it came up in
8 conversation. We were there with three other
9 people; one other New York City DOE person, and then
10 two friends of their's. And initially I just
11 told -- I told the table about the kissing part,
12 that he tried to kiss me, and the table was split.
13 Half said, yeah, report it. Half said, oh, just let
14 it go. But then when everybody went to the
15 bathroom, I started crying at the table, and
16 Kayleigh is like, "What happened?"
17 Now, it's important to note that
18 Kayleigh and I go back to my Canarsie days. Every
19 single day of my teaching life I taught alongside
20 Kayleigh. And I started crying and Kayleigh was
21 like, "What happened?" And I told her that J.G.
22 pulled down his pants and asked me for a hand job.
23 And she told me to report it at that point. And she

1 checked in with me on that Monday to see how I was
2 doing and if I took care of it, and I just said I
3 took care of it, and that was it for that.
4 For August 15th, which was what I
5 refer to as "the assault," I told -- I didn't tell
6 anybody until after I was removed. The first person
7 I told was Mae Chiu, and that was -- I was removed
8 on the 5th. That was probably around the 18th.
9 Maybe a week and a half, something, something like
10 that. And we spoke on the phone. So actually, her
11 number -- you'll see the phone call on my phone
12 record in which that took place. A couple days
13 later I told Jennifer LaMarch. And subsequently --
14 I mean, it wasn't immediately, Ashley Cruz. I told
15 Ashley Cruz. We talked about it in December and
16 January, so I probably told her right around
17 Thanksgiving initially. My friend Gretchen Agans,
18 A-G-A-N-S, down in Atlanta. It was the following
19 year. It was actually September 1, 2015, when I was
20 in Atlanta. Gretchen and I were just talking about
21 life. You know, what's interesting is, when I tell
22 people about this, almost all of them had their own
23 story of sexual assault that I didn't know about,

2 Q. Now, J.G. had testified to multiple instances of
3 oral sex performed by you on him. In any of the
4 messages or conversations that you have with him,
5 are there any references to any of those instances,
6 any discussion about any of them?
7 A. No, because they didn't happen.
8 Q. Was there any reference to the things that you've
9 testified about, the instance we just talked about?
10 A. Yes, many.
11 Q. When was the first time that you became aware that
12 J.G. was claiming that there were these many
13 instances of oral sex?
14 A. When he test -- Well, actually, not when he
15 testified. When the New York Post article came out.
16 J.G. and I never talked about what he told
17 investigators ever. And what gave me insight into
18 the SCI report and what was in it, was that New York
19 Post article. And part of our conversation was,
20 "What the fuck did you tell them?"
21 Q. Now, let's just nail that down in terms of time.
22 The Post article comes out when?
23 A. July 3, 2016.
