DEFINITIONS

To ensure clarity, the following definitions apply to terms used in this Contract:

YOU OR YOUR: The customer named as the Contract holder on the Registration Page.
Bumper-to-Bumper Coverage: Comprehensive coverage of nearly all components of your golf cart, with certain exclusions as outlined in this Contract.

BREAKDOWN: The failure of any covered part under normal use, which prevents it from performing its intended function.

WEAR AND TEAR: The normal degradation of performance or function of a part due to the use over time.

REPAIR FACILITY: Any licensed and authorized repair facility that performs the repairs to your golf cart. All repairs must be authorized by Us prior to being performed.

DEDUCTIBLE: The amount You are required to pay for each covered repair visit. The deductible amount will be listed in the Service Contract Information section of your Registration Page.

OCCURRENCE: A single incident or failure covered under this Contract.

EFFECTIVE DATE: The date on which this Contract becomes active. This is listed in the Service Contract Information section of the Registration Page.

EXPIRATION DATE: The date when this Contract is set to expire or when the total benefit limits have been met, as indicated on the Registration Page.

EXPIRATION MILES: The total miles your golf cart may travel before this Contract expires, or when the limits of liability are reached.

TRANSPARENT COVERAGE

This Vehicle Service Contract ("Contract") is an agreement between You (the Contract holder) and CSP Warranty Agency to provide coverage for specified components and services related to your golf cart. Please read this Contract carefully to understand its coverage, limitations, and exclusions. By signing this Contract, you acknowledge that you have read, understood, and agreed to all terms and conditions.

Eligibility Requirements

To qualify for coverage under this Contract, your golf cart must meet the following criteria:

- Age Requirement: The golf cart must be no more than four (4) years old from the date of its original purchase.
- Mileage Limitation: The golf cart must have no more than 1,000 miles at the time of Contract initiation.

Carts not meeting these criteria are ineligible for this coverage.

Bumper-to-Bumper Coverage

This Contract provides comprehensive bumper-to-bumper coverage for your golf cart, ensuring that nearly all components of the vehicle are protected, except for the listed exclusions. The coverage includes, but is not limited to:

- Electrical Components: Wiring, fuses, battery, lights, and other related components.
- Mechanical Components: Engine, transmission, drivetrain, axles, and brakes.
- Suspension: Shocks, struts, control arms, and related hardware.
- Steering System: Steering rack, tie rods, and steering box.
- Cooling System: Radiator, water pump, and cooling fans.
- Body and Frame Components: Chassis, bumper, and frame (excluding cosmetic damages like paint scratches or dents).
- HVAC System (if applicable): Heating, ventilation, and cooling systems.
- Accessories and Add-ons: Radios, GPS systems, and onboard computers (if factory-installed).

What is Excluded from Coverage:

- Regular maintenance services (oil changes, filter replacements, etc.).
- Cosmetic damages such as paint, dents, upholstery tears, and any damage caused by wear and tear.
- Modifications or aftermarket parts installed after purchase.
- Damage caused by accidents, misuse, neglect, or environmental factors (flood, fire, etc.).
- Tires and tire damage.

Roadside Assistance

This Contract includes 24/7 roadside assistance for the duration of your coverage. The services covered include:

- Towing Assistance: If your golf cart becomes disabled, it will be towed to the nearest repair facility.
- Battery Assistance: Jump-starting or replacing a dead battery.
- Flat Tire Assistance: Replacement or repair of a flat tire.
- Fuel Delivery: Fuel will be delivered if your golf cart runs out of fuel (cost of fuel not included).
- Lockout Assistance: Assistance if you accidentally lock yourself out of the golf cart.

Filing a Claim

In the event of a breakdown, you must follow these steps to file a claim:

Limits of Liability

This Contract provides coverage up to a maximum amount, equal to the Actual Cash Value of your golf cart at the time of the breakdown, as determined by the J.D. Power Official Used Car Guide (or equivalent). CSP Warranty is not responsible for any costs exceeding the limit of liability.

Your Responsibilities

To maintain the benefits of this Contract, You must:

- Perform Scheduled Maintenance: You are required to maintain your golf cart according to the manufacturer's recommended maintenance schedule.
- Report Issues Promptly: Notify Us as soon as you detect any issues with your golf cart that may require repairs.
- Keep Records: Retain all service and repair receipts for the duration of this Contract, as they may be requested to validate claims.
