Critical Race Theory defined

- Academic framework developed by legal scholars
- ✓ 1970s
- Methodology to analyze systemic racism
 Legal system
 Policies
 Education
 Other institutions
 Taught in law schools

Systemic Racism in public schools


- ✓ Special education

Banning CRT in the schools

 \checkmark Co-opted the term Changed the meaning to include Diversity and inclusion efforts ✓ Race-conscious policies ✓ Education about racism \checkmark Advocating for a balanced, civic, and "patriotic" education

NAACP Legal Defense Fund

- Bans of CRT deny the truth about our nation's history, silence dissent, and punish those who speak the truth to counter whitewashed falsehoods
- Attempts to ban CRT are really attacks on free speech, on discussions about the truthful history of race and racism in the U.S. and the lived experiences of black people and other people of color.

The "OTHER" CRT Culturally Responsive Teaching

✓ Research-based approach

Raises expectations and makes learning relevant for all students

 Uses cultural knowledge (race, ethnicity, gender, social-economic status, identity, etc.), experiences, and learning styles to make learning more appropriate and effective for all students

The "OTHER" CRT Culturally Responsive Teaching

 Acknowledges the legitimacy of cultural heritages

 Makes connections between what's learned in the textbook and what's real in children's lives

 Teaches students to know and praise their own and each other's cultural heritages

The "OTHER" CRT Culturally Responsive Teaching

 Incorporates multicultural information, resources, and materials in all the subjects and skills taught in class.

Supreme Court Decision

 School officials MAY NOT remove books from the school library simply because they dislike the ideas in the book

 School officials MAY remove a book from a school library if it is inappropriate for the children of the school.

Book Banning in Florida

✓ HB 1467

- District school boards must report to the DOE any material for which the school district received an objection to
- District school boards report any material that was removed as a result of the objections
- DOE would publish a list of materials that were removed or discontinued as a result of an objection and disseminate the list to school districts for consideration in their selection procedures.


