PERSONAL GUARANTEE

The undersigned, for consideration, do hereby individually and personally fully guarantee and agree that Guarantor shall be personally responsible, jointly and severally, for the full and prompt payment of all indebtedness heretofore or hereafter incurred by the above business together with all other damages and costs which Buyer may be obligated to the Seller, including, but not limited to, legal fees which Guarantor is also obligated to pay as damages to Seller in the event the delinquent account is turned over to an attorney for collection. Notice of the acceptance of this guarantee, extension of credit, modification in terms of payment, amounts of sale, dates of shipments or deliveries, notice of default in payment, and any right or demand to proceed against the principal debtor is hereby waived. Guarantor(s) agrees to notify Seller, in writing, of any changes in the form of the Buyer's business or ownership of Buyer's business within five (5) days of such change, otherwise this guaranty shall extend to Buyer, and any successor companies, individuals or assignees or related entities, as a condition of maintaining an open account with Seller. The obligation of the Guarantor(s), where more than one, shall be joint and several, and the death, discontinuance or discharge for any reason as to one or more of the undersigned shall not operate as a discontinuance or discharge as to any of the others. Any revocation does not revoke the obligation of the guarantors to provide payment for indebtedness incurred prior to the revocation.
