Whereas both parties share a commitment to advancing the Sustainable Development Goals (SDGs), promoting ESG-aligned social impact participation, and enhancing the global visibility of sustainable action data, the parties hereby agree as follows:

1. Purpose of Cooperation

- 1.1 This MOU aims to establish a collaborative partnership to promote sustainable participation via the SDGS PASS system, with quantifiable tracking of impact data and aligned reporting capabilities.
- 1.2 The cooperation serves to empower community and stakeholder engagement through educational, environmental, or civic action missions measurable under ESG-aligned indicators.

2. Scope of Cooperation

- 2.1 Party B will provide the SDGS PASS digital platform, including participation tracking, point management, and reporting services.
- 2.2 Party A may submit local projects, missions, or community initiatives to be integrated as SDGS PASS actions or NTCC-eligible efforts.



2.3 Both parties may co-organize sustainable campaigns, educational challenges, or outreach programs under this MOU.

3. Data Use and Visibility

- 3.1 Party A authorizes Party B to disclose Party A's name, type of partnership, and aggregated contribution metrics (excluding personal or confidential information) as public case references.
- 3.2 Media exposure, co-branding, or joint presentations shall require prior consent of both parties.

4. Term and Renewal

- 4.1 This MOU shall take effect from the date of signing and remain in force for one (1) year.
- 4.2 If neither party provides written notice of termination prior to the expiration, this MOU will be automatically renewed on a yearly basis.
- 4.3 This MOU expresses mutual intention to collaborate and shall not be construed as legally binding. Specific activities may be formalized through further agreements.

5. Miscellaneous

- 5.1 Any amendments or addenda to this MOU must be made in writing and signed by both parties.
- 5.2 Electronic signatures or official stamps shall be deemed valid for the purpose of this MOII.
