    - a. Election Bylaw Discussion
      - i. President: "Is there a motion to open the floor?"
      - ii. KKG motions to open the floor for discussion.
      - iii. President: "Is there a second?"
      - iv. AXΩ seconds.
      - v. President: "What are the questions that you all have about this process?"
      - vi. KKG: "Did we decide whether or not we were still going to allow more than two members from each chapter on exec?"
      - vii. President: "So that is one of the things you all will decide tonight. You all will talk through the options for that."
      - viii. VP Finance & Administration: "In the section about the nominating committee, there were two options, I think they're Point A and Point B, and so it was more of a discussion of which of the two you all preferred."
      - ix. KKG: "Oh, not about the nominating committee, just in for in general, exec positions, if we're going to allow more than two."
      - x. Advisor: "Oh, that's already a bylaw. You can't have more than two. The conversation was for nominating committee, so for chapters that already have two on the board, would you all be comfortable with two members being on the nominating committee or would you like to propose a way that we dwindle it down to just one?"
      - xi. President: "What else?"

- xii. ΔΔΔ: "So, looking at the timeline, the 16<sup>th</sup> of November, the nominating committee and Panhellenic present the slate and the delegation votes on it after y'all have already met, right? So then, if the slate doesn't pass, then does it push it back another week?"
- xiii. President: "So y'all, after speeches, y'all will create your slate as a chapter, and then nominating committee with create their slate from your slates and give it back to y'all on that 16<sup>th</sup> date, on that Wednesday date, the 16<sup>th</sup>, and you guys will see the slate that nominating committee came up with and then if you reject the slate, then you'll go position by position through. Is that what you're asking?"
- xiv. ΔΔΔ: "Yeah, I just wanted to make sure cause I didn't know if people have had issues, like with other schools, have they ever had issues with people not passing the slate and then having to push it back another week, past Thanksgiving, and with transitions...would it be possible the week that nominating committee is meeting, because I'm thinking about how Tri Delt does it, you'll send it out to us and we would have, like, 12 hours to send it back and say yes it is passed or no we don't pass it so that when we come back the 16<sup>th</sup>...do you know what I'm saying? So we don't have to keep pushing it back week by week by week."
- xv. President: "So, theoretically, when you come on the 16<sup>th</sup>, if the slate doesn't pass, there will already be a backup option for the run-off decided by the nominating committee, so nominating committee won't have to reconvene."
- xvi. ΔΔΔ: "Yeah, that's why I was thinking. If there's a backup then..."
- xvii. Advisor: "We'll go position by position."
- xviii. President: "Right, so then if a specific position fails, we'll already know who their runoff partner is."
- xix. ΔΔΔ: "Okay, that makes sense."
- xx. Advisor: "And the reason we can't email it out is because it has to be a formal vote. So when we present the slate it will just be like our formal voting in here, so it would be a more official procedure."
- xxi. President: "Does anybody else have any questions about that?"
- xxii. XΩ: "How exactly does the nominating committee decide the slate from the slates? Is that like...does each member have a vote or is it like they talk about it?"
- xxiii. President: "It's like a group discussion about it. Because theoretically, you can place women who are running in positions that they didn't disseminate in their speech that they want, so they'll theoretically go in position order and talk about it, but they can shift things around as they see fit so it's not just that you get pigeonholed into a specific spot."
- xxiv. Advisor: "The other thing is that based off of that rule where you can only have two members from one chapter on exec, when they're making sense of all of your slates, they're going to have to take things like that into consideration, they're going to have to take things like position requirements into consideration and candidate preferences, what these folks know to be great qualities, so that's why it's a discussion so that they can piece it together with all of those different factors combined."
- xxv. President: "So are there any questions about the logistics of it?"
- xxvi. KAO: "Can you just explain what happens during a run off?"
- xxvii. President: "So let's say that nominating committee and says this is the slate that we want and for some reason, y'all reject it. We're going to go position by position, so theoretically some of them should get approved and then you'll catch the person as you're going through that was probably the reason that the slate didn't get passed. When that happens, nominating committee will have, based on what y'all submitted, will have a second candidate from that speeches pool, whether that's somebody from a different position and how that shuffles around or if it's a person who just based on that information, and then there will be a rote ballot vote, which is 50% majority. So then between those two candidates that we give you, it will just be a majority rules."
- xxviii. Advisor: "And if we had to pull, like let's say it's clear from your slates that you would really love the person that the nominating committee proposed as VP Service & Philanthropy to be VP Management, then we would have to maybe pull that person. Thus why we go in position order"

- because in theory, that position order has some importance and so we may have to vote for two positions depending on how that goes in a runoff style.”
- xxix. President – “What else do you have? Let’s talking through the two options for the nominating committee. Would it be helpful if I read off the two options to everybody? So, the options for your nominating committee, it says that, ‘The nominating committee shall be selected in the following manner: The nominating committee shall be composed of members of the current Executive Board who are not eligible for re-election or who decline to run for office plus the outgoing chapter president from each chapter not represented on the outgoing Panhellenic Executive Board. If the chapter president cannot attend all election processes, she must select the next highest ranking officer from her chapter’s Executive Board.’ Or, ‘The nominating committee shall be composed of members of the current Executive Board who are not eligible for re-election or who decline to run for office plus the outgoing chapter president from each chapter that is not represented on the Panhellenic Executive Board. In the event of two officers from the same chapter serving on the Executive Board...If the chapter president cannot attend all election processes, she must select the next highest ranking officer from her chapter’s Executive Board.’”
- xxx. President: “What are your feelings about how to handle having multiple exec officers on the nominating committee? You can be candid. What are your questions, thoughts, fears?”
- xxx. Advisor: “This is a two-part approach. One, you’re comfortable with exec consisting of whoever is on this board, we know that your bylaws state that it can only be a maximum of two people from one chapter, so you’re comfortable with the exec board serving on it. Option two, you’re not comfortable with that, which would mean a sub-decision if that’s the case, how would you choose between the two members of who will serve on the nominating committee for that chapter.”
- xxxii. ΓΦΒ: “We are fine with having two members from the same chapter on the nominating committee.”
- xxxiii. ZTA agrees.
- xxxiv. ΠΒΦ: “We agree because I think every exec member right now has their own insight into their own position, and I think that’s going to be valuable.”
- xxxv. ΚΚΓ: “We agree, especially after being Panhellenic-minded for an entire year, the fact that there’s two people from one chapter should not make a difference.”
- xxxvi. President: “Is there anybody who disagrees with that idea that would like to propose a way to select between the two officers?”
- xxxvii. Advisor: “Or you can disagree and not have a way to propose and put it up for discussion.”
- xxxviii. President: “Is there anything else that you all would like to talk about?”
- xxxix. Advisor: “I have a question. So do we want to propose that next week we vote on Option A and kick out Option B from the proposal?”
- xl. President: “Is that something that you all would want to do? Do you want to kick out Option B from the proposal?”

- xlii. President: “So that would mean a motion from the floor to kick out Option B from the nominating committee proposal.”
- xliii. ΑΟΠ: “I just have one question. So we wouldn’t even state in the bylaws anywhere that in the event that two women from the same chapter are on exec, they can be on the nominating committee? We’re just not going to write that in?”
- xliv. President: “So, Option A states that if there are, they can both be on the committee.”
- xlv. Advisor: “It actually just states that the exec board serves on it, so it implies that whoever is on the board will serve on the committee.”
- xlvi. ΧΩ: “And if those two end up either rerunning, then it would just fall back on the president, or whoever the highest exec board member is?”
- xlvii. President: “Yes, exactly. If that is how you all feel, would anybody like to propose the elimination of Section 5.B from the proposal?”
- xlviii. ΚΚΓ moves to remove Section 5.B from the proposal.
