- 10. Unfinished Business
 - a. Bylaw discussion
 - i. XΩ opens the floor for old business.
 - ii. KΑΘ seconds.
 - iii. President: “Do you have any questions about this bylaw proposal or comments or concerns?”
 - iv. XΩ: “Did you ever figure out what budget it comes from?”
 - v. President: “So, I didn’t get that answer from Devin, but I actually don’t think that it comes from the Panhellenic budget. I think that it comes from FSL’s budget because they get a stipend for like student workers, so it’s not you all paying the Panhellenic Exec board.”
 - vi. XΩ: “Cause Devin said last time that she thought it would come out of the Panhellenic budget, so has that changed?”
 - vii. President: “To my knowledge, it’s like if you opt in to work/study, then it comes out of their budget, but we can check on that.”
 - viii. ΑΔΠ: “Did you say that you had to be there all three months to opt into it?”
 - ix. President: “I think that that’s a decision you can make with Exec cause that would be an addendum that we’d have to add to opt into it partially, which I guess that we could add if you wanted to. It would be like one-third or two-thirds of the money if you’re only there for certain months. Are there any other questions?”

- x. XΩ: "I have another one. I'm just curious, what's the main goal of doing this? Is it like to get people to stay here over the summer rather than take an internship elsewhere?"
- xi. President: "Well, I guess that's part of the problem...it's also to subsidize the need of the people who are already required to stay here for the summer because they don't have the option to take an internship or a full- or part-time job if they have to be here working on recruitment or if they opt into it then they don't end up devoting the time that they need to to recruitment, and so this just ensures that there is skin in the game for both parties, and then it also gives other exec members who are around the opportunity to subsidize their living cost if they choose to work for FSL over the summer. Anybody else? So, as the bylaw is currently written, it doesn't say whether you can opt in month by month because that wasn't a discussion we had as Exec when we did it, so if there's an addendum that you would like to write, then we can add that in and we can vote on it for next week as well. So, if you want to propose it to us, you can send it to me and Addie, and then we can check on where the money will actually come from."
- xii. KKF: "Can we just get your opinions on this discussion if the addendum was added, would it be beneficial to have someone here even if they can only be here for one month?"
- xiii. President: "I mean, I think you would have to opt into it wholly but you would have to compensate for those 10 hours a week for the months you were missing in the months that you are here. Does that make sense?"
- xiv. VP Management: "So if you won't be there for two months, you have to put in more hours into that month you're going to be there."
- xv. President: "You have to make up that 10 hours a week in the month that you were there."
- xvi. VP Recruitment Operations: "Or you could do it so you only get paid \$500 versus the \$1500 total. That's what I would think. I think that's what we talked about initially, was even if you're only here for one month you get \$500."
- xvii. President: "But she's saying if you only have one month of help is it even worth it?"
- xviii. VP Recruitment Operations: "Personally, I think so. The reason we started thinking about this was because I had an internship this past summer, and so did Ryan, and so we were trying to plan recruitment but also have an internship so we were making money and getting experience, and that was really hard on Devin because a lot of times we weren't in the office when we needed to be, and so this is an incentive to have a paid 'internship', but I could have used way more hands than we had this past summer."
- xix. VP Public Relations: "I would say I was here for all of May and June, but July is the month where if people are going to be there, then that's the month they need to be here, because that's when everything starts picking up."
- xx. VP Service & Philanthropy: "And also it will help with stuff for the next semester so that when we go into the next semester we don't have that awkward lapse of time where we're trying to figure out what to do, if that makes sense. So it can double as working on recruitment, but because we're on top of recruitment stuff, we can also do other things. So, I think it would have been more useful for me as a person who wasn't here this summer to be there because it's hard to play catch up while you're running around during recruitment."
- xxi. President: "Does that answer your question sufficiently?"
- xxii. KKF: "If we want to propose that thing, do we propose it now?"
- xxiii. President: "You would write it up and send it to me, and we'll present it next week. Because you have to put it under the bylaw section where it would be. Or if you have a way that you want it written out, we can work together on it to put it into the bylaw. Is there a motion to close the floor for discussion?"
