- d. ΚΚΓ: "Yeah, so our Kappa Panhellenic specialist recommended changing the term to alternate rather than associate in this particular section so that it wouldn't be misunderstood when discussing provisional and associate members."
- e. President: "Changing it as it stands, so it would read 'Alternate' instead of 'Associate' Delegate? Is that what you're asking?"
- f. ΚΚΓ: "I'm just throwing it out there."
- g. Advisor: "So basically what this is referring to is that there are different categories of membership. We have regular membership, provisional membership, and associate membership. So associate membership would be like if one of our culturally-based organizations decided to come and be affiliated with Panhellenic. They would have a voice but no vote on a lot of matters. Then you have provisional membership like Phi Mu, they're going to be a full-fledged member because they're a part of NPC nationally even if they are not yet chartered as an organization and so once they get that chartering, that ceremony on November 4, they will be just like our other 12 organizations in the room and then obviously regular membership is just like you and your membership right now. What I assume this representative is suggesting is that having 'Associate' might get confusing when we're talking about Associate Delegate versus associate status and so if we were to change this, we would change the term 'Associate Delegate' across the board. So use it as you see fit."
