NPC Update: Second Court Rejects Harvard Efforts to Dismiss Challenges to Discriminatory Policy



New information has recently been released regarding the Stand Up to Harvard court case. This court case developed after Harvard University decided to punish individuals purely off of being a part of a sorority or fraternity. As of January 16th, a second state court judge has denied Harvard's motion to dismiss the legal challenge of single-organizations who are being discriminated against by Harvard University.

This decision confirmed the fact that what Harvard University is doing is not only discriminatory towards women but also ignores the rights of students. According to Emma Quinn-Judge of Zalkind Duncan & Bernstein LLP, a lawyer for the plaintiffs in the

case states that “this decision recognizes what we’ve long known to be true: that sorority members have the rights to freedom of association and should be free from sex discrimination.” This court decision will hopefully motivate Harvard to revoke their discriminatory policy and promote a more inclusive and supportive environment on their campus.
